The President and the Members of the Pondichery Sarafa Merchants' Association hosted a conference of Federation of Jewellers' of Southern Region on Sunday the 18th March 1984 at Hotel Ram International, Annasalai, Pondichery. The Conference was inaugurated by the Governor of Kerala His Excellency Sri Kona Prabhakara Rao, Hon'ble Sri M.O.H. Farook, speaker Legislative Assembly, Pondichery spoke on the occasion. Many members from all the Southern States were represented. Our Association was represented by our President, Sri M. N. Varada Raj, the Secretary Sri K. Hemraj Jain and our director Sri D. A. Sreeramulu.

Problems relating to the Jewellery Trade were discussed and the conference authorised the Secretary Sri P T. Cherian to tackle the same at the appropriate level Unfortunately our Secretary Sri K. Hemraj Jain had a massive heart attack and collapsed at the Hospital in Pondichery. The Body was brought to Bangalore and a condolence meeting was held at the Association. His valuable services to the Association were recorded and as a mark of respect to the departed soul, a Holiday was declared to the Trade on Monday the 19th March 1984.

A Joint Meeting of the Polishers Association Bangalore and that of the members of our Association was held at the premises of our Association on 26-6-1984 to discuss the enhancement of the polishing charges sought by the Polishers' Association. After some discussion a compromise was arrived at the end and rates were fixed. This was circulated to our Members

During the year under review, the sub-committee has functioned very well and has done a commendable job. A Memorandum was submitted to the Hon'ble Minister for Home, Government of Karnataka, (2) The Commissioner of Police in Karnataka detailing the difficulties faced by the members from the Police Department. They have requested our members to take all precautions before they make any purchases. They promised to look into the matter.

Due to the vacancy caused by the sad demise of our Secretary Sri K. Hemraj Jain, Sri E. V. Subbaiah of M/s. Ellore Jewellery Mart was elected as Secretary. Sri P. Nagaraja of M/s. T. A. Padmanabhaiah Setty & Sons was elected as the Joint Secretay. Sri G. S. Eswar of M/s. Ganjam Nagappa & Son (P) Ltd. was sent as a representative of Gold Dealers in the Regional Advisory Committee of Central Excise Karnataka Circle, Bangalore.

Our President Sri M. N. Varadaraj has been elected one of the Vice-presidents and three members namely Sri D. A. Sreeramulu, Sri P. Nagaraja and Sri K. Hemraj Jain were elected as member of the Managing Committee of the Federation of Jewellers of Southern Region. Consequent on the demise of Sri K. Hemraj Jain; another member of this Association has to be proposed in his place.

Our President Sri M. N. Varada Raj is the Vice-President of A I S A, New Delhi. Another name in the place of Late K Hamraj Jain, who was one of the Secretaries is to be proposed.

Some petitions filed by some dealers from different parts of the country in the Supreme Court of India, during the year 1973; Challenging some section of the Gold Contraol Act were dismissed and all the Sections of The Gold Control Act were held valid. Consequently a travelling salesman cannot take out Jewellery for sale to other places other than from his licenced premises. This is a big set-back to the trade. The A I S.A and Federation were requested to tackle the issue.

Handicrafts and Handloom Exports' Corporation of India Ltd., Madras arranged a meeting of all the Jewellers of Southern States at Hotel Palmgrove. Madras on 19-10-84 The Federation of the Jewellers' of Southern Region also arranged a meeting at the same venue in the afternoon. Our Association was represented by our President and the Secretary. The H.H.E.C. requested the members assembled there to increase the Export of Jewellery from South India. A free Trade Zone

Our President requested Sri Giljit Aurora I.A.S., Chairman-cum-Managing Director of H H E.C. to arrange for Bank Loans to our Trade for Export and 10 Print a Brochure Containing the Procedure of Exports to be distributed amongst the trade. He promised to look into the matter. Other Southern States were also represented.

A condolence Meeting was held on 1st Nov. 1984 to condole the sad demise of our beloved Prime Minister Smt. Indira Gandhi. A letter of condolence was sent to the President Sri Zail Singh and to the Prime Minister Sri Rajiv Gandhi The Association declared a Holiday in memory of Late Prime Minister Smt. Indira Gandhi.

The Eviction petition filed by Smt. Nanjamma evicting the premises of Lodging Section of the Association in the High Court of Karnataka was allowed. The Association is granted time to vacate the Lodging Section till 30-6-1986. Our Legal Advisor informed the Association that the Association has no case in going to the Supreme Court Hence it was not persued.

The eviction petition filed by this Association against Sri Raghunandan Prasad Garg and Mr. R. K. Kamath of M/s Kamath Hotel was allowed. The respondents were given time to vacate the premises till 31-10-1984. As a matter of abundant caution, this Association on the advice of Sri G. R. V. Swamy, our legal advisor who conducted the eviction proceedings in the High Court of Karnataka, engaged the services of Sri K. R. Nagaraja M.A. B.L, Advocote Supreme Court, New Delhi to file a Caveat petition in the Supreme Court of India. The Special Leave Petition came up before the Court of Hon'ble Mr. Justice G. A. Desai and Hon'ble Justice R. N. Misra on 28th Sept. 1984. We are sorry to inform the members that the Court granted special leave as well as the stay of dispossession of the premises to the petitioner.


