The President and the other Office Bearers of the Association are Ex-Officio members of all the Sub-Committees.

Beloved President, Hon'ble Members of the Managing Committe and Esteemed members, it is my pleasant privilege to extend you all a very warm and hearty welcome on the occasion of the 23rd General Body Meeting of this Association. One more year has passed, literally 15 months have passed and it is time to present this report to this august gathering. Due to the amendment of the Income-tax Act i.e. fixing of uniform accounting period of year ending i.e., the last working day of March, audited accounts are presented for the year ending 31-3-89 at this juncture. The year 88-89 has been one of certain achievements. Leaving aside for a moment the trials and tribulances of the trade which are not very uncommon, one of the achievements mean the taking over posession of a portion of our own premises which was under litigation for more than 2 decades. In fact a reference to this has been made in the previous year's report also However, even after taking the possession of the premises, the tenant sought intervention of the Supreme Court by putting forth some grievances. Technically and justifiably the sitting Judge of the Supreme Court ruled out the tenants' Contentions and the petition was finally disposed off in favour of the Jewellers' Association. Two tenants are contesting the eviction of the Supreme Court on technical grounds and the same is receiving our attention. For this, your Secretary had to make a hurried trip to New Delhi along with our Advocate Sri Manjunath. Considerable expenditure had to be incurred in this regard.

You are all aware about the functioning of the weighing section from the Chickpet premises also w. e. f. 24-3-1989

### Coming to the taxation problems:

The position of commercial Taxes has not changed. Several memoranda submitted earlier to the Ministry have not borne any fruit. We can only hope that things will improve to the benefit of the Trade & Consumers after the new Ministry takes charge.

A Police sub-committee meeting was held earlier to fix up a joint meeting of all Jewellers and police Officers of the Chickpet Station. The joint meeting was held at the Association premises in Sri Dev Shopping Arcade, Nagarthpet, Bangalore-2 on 6-7-89. The meeting was presided over by the Assistant Commissioner of Police Sri Shivarudraswamy. The Learned Officer highlighted the jewellers; regarding the spate of thefts of jewellery in a number of places like Avenue Road, Chickpet etc. He alerted the jewellers and gave valuable advise on how to avoid such instances and precautions a jeweller has to take

while attending to customers. This Association conveys its deep gratitude to the police officers for their gesture.

Two joint meetings of the Managing Committee Members and the Lodgers were held to discuss certain problems facing the Lodgers. After long discussions, both the representatives of the Association and that of the Lodgers felt that the present rented premises, housing the Lodgers, at Nagarthpet shall be vacated with a month's notice to all the Lodgers concerned. Accordingly the Association has closed down the Lodging Section w. e. f. 30-9-89. Presently there is no Lodging Section for dealers from outside Bangalore and in this regard the Lodgers have represented this Association to accommodate at a different premises: No decision has yet been taken in this regard and decision has to be taken in this matter at the appropriate time.

A course of Diamond Testing & Identification was conducted at the premises of this Association. The Course was initiated by Mr. Ashok Madan Mohan of M/s. Trishul Diamonds, Bombay. Himself an expert in Gemology, conducted the course under the auspicies of the Association. This was for the first time that any such course was conducted in the history of the Association. There was a tremendous response from the jewellery trade, wherein 69 member-jewellers participated and took the training. The enthusiasm shown by the members (most of them youngsters) is really laudable. The overall opinion of the trainees was just one word 'excellent' and was very beneficial for the beginners. This Association thanks the concerned Agency for having imparted training.

A meeting of the Federation of the Jewellers of the Southern Region was held at Madurai on 24-10-89. Representatives from all over Tamilnadu and that of States namely: Karnataka, Andhra, Kerala, Pondicherry, represented the meeting. Various problems facing each section of the trade were putforth and a threadbare discussion was made. The main topic to be discussed and a decision arrived at was: (a) abolition of Gold Control Act which has become obsolete as the same has failed to achieve any of the objectives, (b) having a uniform levy of sales tax in all States and the rate of tax to be not more than 1% (as the Gold and Silver prices have sky-rocketed), (c) to evolve a formula regarding the vagaries of the Police department in involving the innocent jewellers who do not purchase old jewellery from unknown people. The final consensus was that due to a fraction of black sheep in the trade; the majority of genuine dealers are suffering. It is not only in Karnataka and other Southern

As you are all aware it is a very happy development that the Central Govt. has recently established a full fledged Receipt-cum-Delivery Centre for Gold at Madras from 27-10-89. A Circular has already been sent to all the members and it is hoped that the members will take the full benefit of the same. In fact for more than a decade; your Association had been relentless y representing the concerned Ministry to open Refinery and assaying Laboratories all over the major cities of India. Bangalore specifically requested a refinery to be established here but only Madras got the facility of a Receipt-cum-Delivery Centre. It is hoped that a least in the near future one such centre would be started at Bangalore. If the quality control has to be effective and the consumer is to be protected, such facilities are very essential.

Your Hon. Secretary who is a co-opted member in the Regional Advisory Committee, Central Excise had literally no work, as no representation of any sort was putforth to the Association.

From the export side, it is Bangalore that contributes to the majority of the Jewellery Export from South India till date. At the recent meeting of the FJSR held at Madurai; your Secretary, who represented this Association submitted a Memorandum to the President of the FJSR to take necessary measures to recognise Bangalore in the Export map and see that jewellery meant for Export from Bangalore is valued at Bangalore it self, instead of Madras as is being done now, which would save valuable time and money to the Exporter and also avoid the risk of taking the jewellery to Madras every time. The Federation has assured that necessary action will be taken in this regard.

Our Local Auditors Sri Sakala R. Prakash of M/s. Sakala Jewellers & Sri C. G. Nagaraj of M/s. Navarathna Jewellery Mart, Bangalore have done their services sincerely and efficiently. I thank them on behalf of all the Managing Committee members and on your behalf for their devotion to duty

It is needless to mention that the staff and that of weighing sections have been discharging their duties well.

l place on record the valuable services rendered by our Advocates Sri C.R.V. Swamy, Sri Krishna Murthy Iyer, Sri Manjunath and Sri K. R. Nagaraja of New Delhi in the Supreme Court case.
