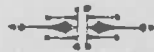

Fashion shows could be arranged along with the Gold Council who are definitely going to help under these circumstances. All our big budgeted programmes could be arranged by a group of Jewellers and the Council. This association will try to do its best for such kind of sales promotion. We have to stress the importance of quality orientation coupled with modern trends in Designing. If the trade is to sustain the competition of the electronic age of super gadgetry and consumer goods, the trade should act from new itself. Diversion of funds to the other markets are to be slowed and stress should be made to see that an individual should set apart a major share of savings to buy Gold. For this, quality should be the watch word and should not be compromised.

10. The Association participated in the Blood Donation Camp organised by the Lions Club of Gnanabharathi Complex and Raja Market Ganapathy Seva Mandali in the premises of our Association on Monday the 12th September 1994. About 40 bottles of blood were collected and given to the Victoria Hospital. We are thankful for all the blood donors.

So for the earnings are medio core because of the expenses involved. But it is the service that counts and we hope that more and more people will utilise its services.

12. The Building Renovation Committee, under the chairmanship of Sri B. K. Manjunath, Sri P. V. Rathan Kumar, K. S. Manjunath & Sri T. R. Sathanarayana-Setty The Members of the Committee who are also the directors has done a splendid job. The renovation is being done in a phased manner because of space constraints and other problems. 13. Our tryst with the Sales Tax problems are as usual. We have of course got a major concession as the tax rates are reduced to 2% F.S.P. from 4% on M.S.P. Exemptions can be claimed from the 2nd sale point. Surcharge of 15% on sales tax is for sales on Jewellery only and not on Bullion sales. If any member faces problems in this regard, Tax Consultants' help has to be taken as some sections of the law are ambiguous and prone for wrong interpretation. We always have doubts and it is sorrowful to note that the department is unable to give clear cut verdict and hence assessments are being delayed. This will be pursued with New Government.

14. Regarding the eviction of the shop and the petty shop of this Association occupied by one Mr. Hemraj Jain and one Mr. Ananthaiah the matter is pending with the Supreme Court of India. We are persuing the matter.
