1. The Managing Committee of this Association is glad to place before you the Audited Balance Sheet, Receipts and payments accounts and Income and Expenditure account for the period 01-04-1994 to 31-03-1995, 01-04-1995 to 31-03-1996 and 01-04-1996 to 31-3-1997 (Three years).
2. During the period; there were 295 members as on 01-11-1997.

3. The sub committee constituted upto 31-03-1996 for conducting various activities continued till the presentation of this report as there was no change in the constitution and I thank all the conveners and members of the sub committees for their performance.
4. Our local Auditor Mr. N.R. Narasimha Setty of M/s. N.R. Narasimha Setty & Sons, Avenue road, Bangalore and Mr. Jagadeesh Prasad of M/s. Ratna Mahal, Avenue Road, Bangalore rendered good services and I thank them on behalf of all the Managing Committee Members and on your behalf for the same.
5. The panel of Sriyuth, M.N. Varadaraj, D.A. Sreeramulu, C.L. Varadaraj Gupta, K.A. Ramu, E.V. Subbajah, T.R. Satyanarayana Setty and K.S. Manjunath which had been constituted to perform the duties of appraising the jewellery meant for export from Karnataka has been doing the work satisfactorily. I thank them on behalf of this Association.
6. I also extend my heart felt thanks to M/s. Anand & Vasudev, Devi Krupa Building, C.T. Street, BANGALORE, Chartered Accountants for their timely submission of Audit Report.

7. Our Receipts have increased over expenditure by Rs. 7,50,535.60 for the year 1994-95 and by Rs. 4,40,360.81 for the year 1995-96. This is an all time increase and is attributed to the fact that the major revenue has been from the appraisal charges received from the Exporters. After paying honorarium, the Association has received a net income Rs. 11.91 lakhs for two years.
8. Newly elected corporators of Nagarthpet and Chickpet wards were honoured by the Association on 24-11-96 at Bangalore South Rotary Trust, K.R. Road, Bangalore.
9. The Association has reduced the appraisal charges of gold and silver ware and other allied items from the existing rate of 0.05% and 0.03% with effect from 11-12-96 as some exporters requested the Association to reduce the appraisal charges subject to a minimum charge of Rs. 200/- and maximum charge of Rs. 1500/- to members and 0.06% to the non-members.
10. The president and the immediate past president Sri. D.A. Sreeramulu and Sri. M.N. Varadaraj attended the M.R.T.P. Meeting held at New Delhi on 16-11-1996.
11. A sum of Rs. 3,000/- has been donated to Xth World Sanskrit Conference on 28-12-1996.
12. The Jewellers' Association submitted a memorandum to the concerned authorities to reduce the Sales Tax structure in the state of Karnataka in January, 1997.
13. The video show of the Delhi Exhibition was arranged for the benefit of our members on 13-05-1997 between 10.30 A.M. to 6.30 P.M. in the Nararthpet Association Office.
14. As customs authorities insisted to execute appraisal work at Air Cargo Complex; the Association is carrying out the appraisal work at Air Cargo Complex with effect from July, 1997.
15. A Technology seminar was organised by the World Gold Council at Hotel Atria, Bangalore on 2nd and 3rd of July, 1997.

Different aspects of alloying pure gold into 22Ct. and 18 Ct. were explained by the three Metallurgists Mr. Peter . M. Raw, Mr. Mark Grimwade, Dr. C.W. Corti.

The Seminar was highly educative as the modern methods of purification of gold was dealt and explained in detail (in the two days seminar by the three experts).

The renovated premises of our Association Building was inaugurated on 6-9-95 by Sri. K. Sreenivasan, I.P.S. Additional Director General of Police, Prisons, Govt. of Karnataka, Bangalore.
