4. Our Local Auditors, Sri Jagadish Prasad of M/s Ratna Mahal Jewllers & Sri Raveendra of M/s Jayalakshme & Co., rendered good services and I thank them on behalf of all the Managing Committee Members and on your behalf for the same.
5. The panel of Sriyuths, M.N. Varadaraj, D.A. Sreeramulu, C.L. Varadaraj Gupta, K.A. Ramu, E.V. Subbaiah, T.R. Satyanarayana Setty and K.S. Manjunath Which had been constituted to perform the duties of appraising the jewellery meant for Export from Karnataka State has been doing the work satisfactorily. I thank them on behalf of this association.
6. I also extend my heart-felt thanks to M/s Anand & Vasudev, Devi Krupa Building, C.T. Street, Bangalore, Chartered Accountants for their timely submission of Audit Report for the year 1997-98 and 1998-99.

Our receipts have increased by Rs. 99,617-49 for the year 1997-98 and Rs. 4,91,744-18 for the year 1998-1999. This is an all time increase and is attributed to the fact that the major revenue has been from the appraisal charges received from the exporters.

As you are all aware that with the staunch efforts of the Association, the tax on bullion was reduced from 1% to $\frac{1}{2}$ %, single point, without Turn-Over Tax. The tax structure on jewellery was reduced to 2% from 4% and turn-over Tax was exempted totally. This was upto a period ending 31-3-1998. From 1-4-1998 the Government Brought Back the Tax Structure on Bullion to $\frac{1}{2}$ % multi point and re-introduced turn-over tax on the second

sale and further. In the pre-budget meeting, we had represented to the Finance Minister to retain the Tax on Bullion at 1/2% single point without turn-over Tax. The Finance Minister and the Departmental authorities were not clear as to maintain the structure. They insisted that the revenue from the jewellery Trade had not shown any increase even after reducing the Tax structure. We made it clear to the Finance Minister and other authorities, the Government has got a revenue of Rs. 30 Crores and there was no need to enhance the Tax Rates which would have an adverse effect on the trade and the revenue got from the Bullion Sector would be lost. However, the Government thought that more revenue could be got by increasing the rate to 1/2% single point plus levying turn - over Tax from 1 - 4 - 1999. The entire Bullion Trade in Bangalore had to be closed down as we became in - competitive. Neighbouring States, Tamilnadu and Andhra Pradesh reduced the Taxes to 1/2% single point and scrapped turn-over Tax.

In this context, our President of the Association had to give a press statement along with some of the leading Jewellers in the 'TIMES OF INDIA' the adverse effect due to the proposed hike. But our Government was not in a listening mood. Finally, the State had to loose the entire revenue.

A detailed Memorandum was submitted to the Finance Minister and Senior Officials concerned which did not evoke any response.

However, to show the Government that the Trade is sincere in its effort to increase the State revenue, we appraised the Finance Minister and others the efforts taken by the Association. In creating Tax awareness, as said earlier during face to face interaction with the Commercial tax department along with the World Gold Council, we are now keeping our fingers crossed that with revenue from bullion already gone, the Government may revert the tax on Jewellery from 2% to 3% or more.

The sales Tax sub - committee was further strengthened by the inclusion of M/s G.V. Hayagriv, Mr. Vinod Hayagriv of M/s. C.K. C, Y & Sons, M/s. G.S. Eshwar & Umesh of Ganjam Nagappa & Sons, Sri Mahesh Rao of Peakok exports, Mr. Rajesh & Prashanth Mehta of Rajesh exports, Mr. Ramesh of Davanam exports, Mr. Girish from Jaysons and Mr. Suresh Dhruv of Bangalore Refinery.

As committed to the Government, the Sub - committee along with the Office bearers worked relentlessly meeting the concerned authorities telling them the various projects like creating Tax awarness and appealing to the Trade to put its best efforts to boost up the trade etc., After the interaction at the Taj Residency, the committee met the Commissioner along with Mr. Michado and Mr. Shivaram of World Gold Council. The result of which is that the tax structure on Jewellery is retained at 2% single point and no turnover Tax.

It is proposed to continue our efforts of retaining the existing Tax rates by continuing the Advertisements, viz., erecting of Hoardings, putting up banners etc., This means lot of expenditure, half of which is to be borne by the World Gold Council and the rest by the Association. I appeal to all the traders to contribute their mite to the Association's

Tax awareness campaign. Two circulars have already been sent to all the Members and even to Non - Members also and I expect the trade to come forward in fulfilling this arduous task. M/s. Swarna Jewellers, Gandhinagar, Bangalore, M/s Abharan Jewellers, Bangalore have contributed Rs. 30,000/- each to meet the expenditure. Other prominent jewellers have promised to contribute for this purpose. Without your support, the goal cannot be reached.

I do hope that the new Government would definitely look into the matter seriously and will need our suggestion thereby reviving the Bullion Trade which will ultimately be a boost to the jewellery sector, by retaining the Tax structure which could be retained at the existing rate of 2% single point and no turnover tax.

This Association has purchased pager on 22 - 8 - 98 from M/s D.S.S. Mobile Communication at a cost of Rs. 3,600 /- and a Fax Machine on 24 - 2 - 99 from M/s Godrej Boyce Manufacturing Co. Ltd., at cost of Rs. 12,750 /- for the benefit of the Association Members Trade activities. On 27 - 1 - 98 Pre - budget proposal was submitted to the concerned authorities.

A meeting with Commercial Tax Officers Sri. Madhu and his Officers was arranged at Hotel Taj residency on 7th Dec. 98 to have face ot face interaction with the trade members by the Jewellers' Association in consultation with the World Gold Council. To meet the expenditure incurred, the following members have sponsored to the tune of Rs. 40,000/- as follows.
