4. Our Local Auditors, Sri. Jagadish Prasad of M/s. Ratna Mahal Jewellers & Sri. Ravendra of M/s. Jayalakshmi & Co have rendered good service and I thank them on behalf of all the Managing Committee Members and on your behalf for the same.
  5. The Panels of Sriyuths, M.N. Varadaraj, D.A. Sreeramulu, C.L. Varadaraj Gupta K.A. Ramu, E.V. Subbaiah, T. R. Sathyanarayana Setty and K.S. Manjunath which had been constituted to perform the duties of appraising the jewellery meant for Export from Karnataka State and has been doing the work satisfactorily. I thank them on behalf of this Association.
  6. I also extend my heart-felt thanks to M/s. Anand & Vasudev, Devi Krupa Building, C.T. Street, Bangalore, Chartered Accountants for their timely submission of Audit Report for the year 1999-2000, 2000-2001 and 2001-2002.

Our receipts have increased to Rs. 6,96,045-87 for the year 1999-2000, Rs. 7,13,103-89 for te year 2001-2002. and Rs. 6,54,191-34 for the year 2001-2002, This increase is attributed to the fact that major revenue has been from the appraisal charges received from the exporters.

This Association has made a representation to the then Finance Minister, Government of Karnataka to rope in more jewellers into the Tax Net.

2. Turnover Tax on U.R.D. purchases should be removed.
3. Tax on precious stones to be reduced to 2% and exempting the same from the

incidence of Turnover Tax.

You are all aware that the Turnover Tax was abolished and the tax on precious stones was brought down to 2% single point.

The Association has made a representation to the Commissioner of Commercial Taxes, Government of Karnataka on 7-3-2002 requesting him that the rate of Tax on works contract may be brought down from 4% to 2% as is the rate of Tax on jewellery.

You are also aware that the bill on Value Added Tax (V.A.T) has been passed by the Legislature of Karnataka and is pending approval by the President of India.

Under the Value Added Tax (V.A.T) bill the rate of tax applicable on bullion & jewellery is likely to be 1% which is favourable to the Jewellery Trade. Regarding penalties under the Value Added Tax (V.A.T) bill is rigorous.

All the Associations with the help of Federation of Karnataka chambers of Commerce & Industry have observed hartals and made representation to reduce the same.

A Pre Budget Meeting between the Government of Karnataka and all the Traders of Bangalore was arranged at the Conference hall, Vidhana Soudha. Our Association was represented by the immediate past president and now the Taxation Committee Chairman Sri. M. N. Varadaraj and the President Sri. D.A. Sreeramulu along with the Joint Secretary Sri. B.K. Manjunath. A Memorandum highlighting the Jewellers opinion was submitted to the Chief Minister who had presided over the meeting. The then Commissioner of Commercial Taxes Sri. Madhu I.A.S., and the Additional Commissioner Sri. Narasimhan were also present.

A copy of Memorandum was submitted to Sri. Narasimhan, Additional Commissioner personally by Sri. Sivananda the then manager of the jewellers Association.

A Diamond identification course was conducted jointly by the Gem & Jewellery Export Promotion Council, Chennai and our Association at Hotel Lucia International, Bangalore. Mr. Ruban Hobday, Regional Officer, South, Chennai was instrumental in organising the course. The 5 day course was attended by 35 members from Bangalore including one from South, like Mayiladuthurai, Tamilnadu.

On 14-4-2000 Certification Award Function was celebrated and all participants were awarded with Certificates from the Gem & Jewellery Export Promotion Council and also from the Jewellers' Association, Bangalore. Invitees and Chief guests were felicitated.

Gold Melting Furnace was demonstrated at the Association Premises from 10th April to 14th April, 2000. by Therelek Engineers Private Limited, Bangalore - 58.

A meeting was organised by the Gem & Jewellery Export Promotion Council at Hotel Ashok, High Grounds on Karnataka State Taxes, (direct & Indirect taxes.)

The Meeting was chaired and addressed by Sri. Ramjethmalani, Union Minister for Law, Justice & Company Affairs. The meeting was attended by two representatives from the Association.

An interactive meeting with Sri. P.A. Krishna Murthy, Director of Legal Metrology, New Delhi & Sri. V.B. Patil I.A.S., Controller of Department of Metrology, Government of Karnataka was arranged by Federation of Karnataka Chambers of Commerce & Industry, for discussing Weights and Measures Act Rules. The Meeting was attended by the members from the weight & Measures Committee at the Cabinet Hall of Federation of Karnataka Chambers of Commerce & Industry.

Mr. Shashikant Jariwala got himself elected to the working committee of the prestigious Council of The Gem and Jewellery Promotion Council, Mumbai which commands over 36,000 crore of export of Gem, Diamond and Jewellery. His election is the first from the South. Subsequently he was also made the co-conveyer of the southern region and also a member of All Indian Gold Panel. He is actively participating in the promotion of export activities etc.

A meeting was arranged at Kunchatigara Sangha, Kilari Road, regarding self assessment of property Taxes by the Bangalore Mahanagara Palike (Corporation of the City of Bangalore). The Association was represented, D.A. Sreeramulu, Sri E. V. Subbiah and Sri B. K. Manjunath.

An interactive session with Sri. Yaswanth Sinha, Union Minister of Finance was arranged by the Federation of Karnataka Chambers of Commerce & Industry at Hotel Ashok, Bangalore. Two representatives from the Association participated in the meeting.

An informal Meeting of the State Trading Corporation, was arranged at their premises on the 22nd of June, 2000.

Our President Sri. D.A. Sreeramulu, and myself as the Hon. Secretary, E.V. Subbiah and Hon. Joint Secretary Sri. B.K. Manjunath along with other Bullion Merchants attended the meeting.

A farewell felicitation meeting was arranged at Chowdaiah Memorial Hall to felicitate Sri. T. Srinivasulu I.P.S., outgoing Commissioner of Police, Bangalore. Glowing tributes

were showered on the services rendered by the commissioner to the public. Chief guest of the occasion Sri. S.M. Krishna as the Chief Minister, and Hon., Home Minister Sri. Mallikarjuna Kharge had graced the occasion. Our Association was represented by the Joint Secretary Sri. B.K. Manjunath and Managing Committee Member Sri. B.H. Ramachandra. This meeting was organised by Bangalore Citizens Forum.
