EVENTS OF THE YEAR 2004-2005

I am happy to express soon after the new managing committee took charge of the Association, an interactive meeting was held with Sri Shivrām, Vice President, World Gold Council, at the renovated premises of Nagarhpet Office on 17-11-2004. The agenda was to streamline the strategy of selling more and more Gold Jewellery in the coming years. The present scenario of globalization, foreseeing a booming economy in India. It was felt that the Gold Jewellery should serve the consumers by assertive & aggressive marketing. Mr. Shivrām highlighted the importance of improving designs and promote quality jewellery. Unlike any other trade Gold Jewellery is always subject to a thorough analysis. Even while selling small piece of jewellery by tradition and by habit the customer is to be given the details of pricing viz., cost of gold, making charges & all. It was mooted in the meeting an effort could be taken to sell small pieces of Jewellery @ MRP (maximum retail price). The idea could be well received and it is high time that the trade would start doing so. A good lot of branded jewellery have entered the market and most of them, especially the diamonds studded ones are marked as MRP (maximum retail price). This could ease the traders woes of giving the analysis of the ornaments sold. A broad based policy of value addition on the cost of raw material could be adhered to.

FKCCI MEETINGS :

After the union budget, in the meeting held at the FKCCI, three main points were to be discussed viz., Service Tax (the applicability of this to the Jewellery Trade) Value Added Tax, and Income Tax. A memorandum was submitted to the central government. It is now clarified that gold and silver jewellery trade is out of the purview of service tax. Implications of VAT were discussed. Sri D.V. Ramesh took active part in the interaction.

HUTTI GOLD MINES VISIT :

On 7-1-2005 the managing committee visited the Hutti Gold Mines on the invitation from the top management of the state owned company. All the members were taken inside the mines and whole team was happy. It was very educative and after the visit we were all entertained to dinner, lodging and boarding was arranged by the management. Our director Sri Suresh I. Druv was the main anchor for this visit. I personally and on behalf of all the members thank Sri Suresh and the management of the Hutti Gold Mines Company. A second team was sent from here a month after this event.

On 1-2-2005 a discussion was held at the Association premises with Mr. Sumesh Wadhera, Chief of "The Art of Jewellery" magazine regarding a proposed gold festival starting from 4-4-2005 and it was unanimously decided that the gold festival be conducted as per schedule. This year the highlights of the festival being the participation of jewellers' from all over Karnataka. On 23-4-2005 there was an interactive meeting at The Bangalore City Institute regarding the proposed introduction of VAT. A large number of our members, as well as non members attended this meeting and opinions were exchanged.

When all discussions were being held involving VAT and other related issues there came the sudden jolt from the Central Excise Department about the levy of 2% central excise duty on gold ornaments. The interpretation of central finance minister Hon. P.C. Chidambaram's announcement, was assumed to be applicable on all the Jewellery Trade. As no proper clarification was forthcoming your representatives met the commissioner of central excise and submitted memorandum highlighting the problem. There was a token strike and a Bundh was observed by jewellers all over India and the central government was quick in noticing the commotion and clarified that the Levy is applicable on Branded Jewellery only citing examples. The Association Managing Committee was also accompanied by Sri Eshwar of Ganjam Nagappa & Sons and Sri C. Vinod Hayagriv of M/s. C. Krishnaiah Chetty & Sons leading jewellers of Bangalore. After the required clarifications were given, the Trade heaved a sigh of relief.

A seminar was conducted at Hotel Gold Finch on VAT Eminent Taxation Consultant on VAT Sri Venkataramani addressed all the members allaying the fear of the traders. However a token protest was observed by the Jewellers all over Karnataka on 10-3-2005 by closing their establishment.

Further clarifications were given by Taxation Expert on central excise Sri Ravi Shankar on 8-3-2005. A booklet was circulated to all our members, on VAT and Central Excise.

As decided unanimously the Gold Festival was conducted from 4-4-2005 to 25-5-2005 coinciding the period of the Auspicious Akshay Trithiya. A total of 5 kgs of Gold was given away to customers as prizes.

The Annual Jewellery show the India International Jewellery show was held in Bombay from 14-7-2005 to 18-7-2005. In spite of very bad weather and heavy rain more than 1200 jewellers had participated.

The Annual Gold Festival organised by the Jewels of India and co-sponsored by the Jewellers' Association Bangalore was held at Sri Kanteerava Indoor Stadium in Bangalore. There was a participation of more than 100 Jewellers from Bangalore and other places.

There was a Jewellery & Gems show in Sri Lanka from 31-8-2005 to 3-9-2005. Circulars were sent to all our member Jewellers informing about this event which was from 31-8-2005 to 3-9-2005.

On 4th & 5th of October a demonstration and free service camp was conducted at the Association Premises for Sartorius Weighing Balances. A large number of jewellers availed this facility.

In the 2nd year of my tenure as the Hon. Secretary I am glad to submit this report to all of you and my team is giving excellent support in all the activities.

This Association has donated a sum of Rs.45,000/- to Tsunami Relief Fund through our director Sri Vivek B. Chand. A sum of 62,000/- has been collected and paid from Jewellers of Bangalore in their individual capacity who requested anonymity in their Act of this Noble Task.

MEMBERSHIP DRIVE :

It was proposed to enrol more members into the Association. Hon. Secretary Sri P.V. Mahesh and Sri Sreedhar took the initiative and were ably assisted by the manager Sri T. Narasimhulu & staff Sri T. Venkataramana in enrolling nearly 52 new members.

Finally, I thank all the members of the Managing Committee, Conveners and the Sub-Committee members for their unstinted co-operation extended to me during the period.

I whole heartedly thank the staff of the Association for their hard work in executing day to day affairs of this Association.

I thank you all and expect the same kind of co-operation from your side in all time to come.
