Sri Shankar Bidari was thanked by Sri G.V.Sreedhar for gracing the occasion.

Sri Venkatesh Babu requested Sri Vinod Hayagriv to highlight on the present critical conditions of Jewellery trade. Sri Vinod Hayagriv, the chairman of GJF said that Exports of our Jewellery Graph, show a downtrend. The Jewellery Industry is facing a tough time as there is no uniformity in rates throughout India. He said that GJF's main aim is to implement uniform rates through out India. He also mentioned that The Jewellers' Association, Bangalore, is the best administrative Association in India.

Sri Ajit requested the President Sri P.V. Mahesh to call on the 35th A.G.M.

Sri P.V. Mahesh, readout the proceedings of the 34th A.G.M. and asked the members for their approval. Sri B.H. Ramachandra, one of the members enquired about the sealing limit of the members, for which Sri P.V. Mahesh mentioned that six hundred members is the membership sealing limit, there after the new members will be called as Associate Members.

The Associate Life Members will have all facilities except voting power and will not be able to contest the elections. They will get the voting power and can contest the elections after the completion of one term (i.e. 3 years)

Sri P.V. Mahesh also mentioned that the term for the Mentor will be for five years, after which the new mentor will be selected again in the A.G.M. by the members. He should have experience and high knowledge in Jewellery Trade. He will have all rights of the Committee members except voting power.

Regarding corpus fund in our Association, Sri D.V. Ramesh informed the members that it is reaching close to Rupees Two Crores. He also informed that the funds shall be ratified from time to time to get higher interests.

Sri P.V. Mahesh mentioned that every year, the A.G.M. will be held either in the month August or September.

Sri Nagaraj asked the President about purchasing the property for Association for which Sri P.V. Mahesh said that we are looking for it and it will be finalized as soon as a suitable property is indentified. Sri Nagaraj said that after purchasing the property for the Association they should build Samudaya Bahavan which should be useful for the society.

The members approved the continuation of the Auditor, Accountant and the Local Auditors for the ensuing year.

The members also approved the budget for the ensuing year.

Sri Pratap Kamath was requested to read out the members of the newly formed sub-committees, which also included members from outside the Board.

Sri Ajit requested Sri Chetan to readout the names of sponsorers. They were thanked and momentos were given by the Association.
