## from the PRESIDENT'S DESK



### Dear Esteemed Members,

Firstly I would like to Thank the members & the Board for providing me an opportunity to serve the jewellery fraternity by selecting me as The President of the Prestigious Jewellers Association Bengaluru (JAB). I am grateful for all your faith and confidence bestowed on me.

As we witnessed today jewellery industry is facing real challenges as never before. Government of India has increased customs duty from 1% to 10% which has burdened the citizens and affecting purchasing power.

The restriction on import of gold has been levied by Commerce Ministry, hence the banks have stopped selling gold on loan basis, which has hit manufacturing sector and also increased financial cost.

Ministry has fixed 80:20 ratios for exports which have resulted in almost zero imports from the past few months. Due to this our industry is coming to grinding stand still which is not a good sign for Indian economy.

Our industry has witnessed both highest - lowest extreme points in terms of business. At the time of Akshaya Tritiya, industry witnessed tremendous increase in the business in the month of April & May. But when the ban on Gold was Imposed in the month of August & September, industry had a fatal blow & the business had came to stand still, where most of the artisans were rendered jobless.

### Country comes first:

To support the CAD issue, The Team JAB as per GJF'S Initiative had requested our members to temporarily stop selling Gold Bars and Gold Coins which has helped government to reduce CAD and ours was the first association to act in this regard for which I Thank all the members who supported the cause.

JAB has achieved a great milestone by conducting educational seminar with the co-ordination of GIA, the seminar "EVOLVE"- A leadership conclave is the BEST of its kind in the country. JAB conducted Rifle Training Program in co-ordination with Police Department. We had organized a meeting with police department in creating awareness related to safety and security of the jewellers.

As a Social Responsibility of JAB, My dream of conducting organ donation is coming true.

We believe that we are in the process of building a strong association which will emerge as model association in India. I am a firm believer in bringing in new acumen and thoughts. This will bring in new ideas and re-modulation. I encourage and call upon the youth of our industry to serve the association to take it to greater heights.

I would like to express sincere gratitude to all the members for being given me the opportunity to serve the prestigious Association as the President with the wonderful co-ordination and hard work of the Secretary and Treasurer and the entire TEAM of JAB.

## The Struggle for Silver Standard

(The Silver Committee Report)

**Fact:** "99" silver, standardized by JAB, is today the preferred silver bullion in most silver centers of south India, like Chennai, Kolhapur & Hyderabad.

The Struggle- Three years back the purity of Bangalore local silver was suspect and also the least preferred by other centers. In such a scenario the JAB set up the Silver Committee to clean up the silver bullion issues & to provide a reliable standard for the silver Trade.

The committee took all sections of the Trade into confidence and persuaded them for 99% purity standard for local bullion. Initially the going was not easy, but after an effort of one year and a series of meetings & interactions, the 99 standard was achieved.

Even after that periodically minor problems arose and the committee was able to adapt & make changes to overcome those glitches. Random testing's on a regular basis is done today to maintain the standard, and if deviations are found immediate corrective measures are taken.

The committee also looks into all Trade related matters, as and when required, to maintain a cordial relationship among various sections of the Trade like melters, assayers, refiners, bullion dealers, silver smiths and silver traders.
