## From The **PRESIDENT'S DESK...**



Dear Members,

The Gems and jewelry sector in India plays a significant role in the Indian economy, contributing around 6-7 per cent of the country's GDP. The government of India has declared the sector as a focus area for export promotion based on its potential for growth and value addition. The government has recently undertaken various measures to promote investments and to upgrade technology and skills to promote brand India in the international market. Prime Minister Modi's 'Make in India' manufacturing initiative has placed a great deal of emphasis on the Gem and Jewellery industry being one of the key thrust sectors for pushing growth and exports. The positive effects of these steps will be seen by the industry in the coming months and years ahead.

The coming year marks the 75th year of our association. To mark this momentous occasion, we are planning to celebrate the Platinum Jubilee over a 2 day period while having cultural and family events. The 2nd edition of the gold quest treasure hunt was held in the month of August after many requests from members to make this an annual event. Over 200 people participated in this event which fostered camaraderie amongst the members and their family & friends.

A much needed renovation was undertaken and completed to our office premises in Nagarathpet in May after a period of over 10 years.

A XRF gold testing machine was bought by the association which accurately confirms the purity of the sample using non destructive and non intrusive methods. Members can avail of this facility by paying a small fee.

I would like to thank the members of this prestigious association for bestowing on me the chance to serve the industry over the last one year. I would also like to take this opportunity to thank the sponsors for their support.

# PROCEEDINGS OF THE 40th ANNUAL GENERAL BODY MEETING

held on Sunday, October 19th, 2014.

at Elaan Convention Centre, Puttenhalli Road, Phase 7, Opp. Brigade Millennium, J. P. Nagar, Bengaluru - 560 078.

The proceedings commenced at 10.00 a.m. The master of ceremonies, Ms. Reena D'Souza, requested The President of the Association, Mr. P.V. Mahesh to occupy the chair. She also called upon all the Managing Committee members of the Association on to the dais.

The Hon. Secretary, Mr. Y.S. Ravikumar, read out the notice for the meeting and this was followed by the Invocation.

The Lighting of the Lamp was performed by the Committee Members and a few senior members.

A moments' silence was observed as a mark of respect to the departed members and their families.

The Hon. Secretary Y. S. Ravikumar gave a welcome speech. He said the branding of the Association in the national platform is one endeavor that was in progress.

This was followed by the presidential speech by Mr. P.V. Mahesh. He respectfully acknowledged the contribution made by all the previous Committee Members in the past years of this 73 year old prestigious Association.

The President solemnly announced that five members of the Committee had given in their resignation and that the Hon. Treasurer T.N. Sandeep also intended to perform his duty for the day and then resign. He confirmed that he had not accepted their resignation yet and therefore invited all the Committee Members to come on to the dais and conduct the AGM. He also extended his invitation to talk matters over and resolve the conflict. However, the said Committee Members refused to take their seats on the dais.

The Committee Members and the General Body began discussing the issue on hand. The atmosphere was tense. Committee Member Mr. G.V. Sreedhar and The President Mr. P.V. Mahesh, along with other Committee Members, questioned each other and brought to light the issues involved. The president Mr. P.V. Mahesh called the House to order.

The Committee Member, Mr. B.R. Ajit Kumar took over. He expressed his dissatisfaction and said that the Election procedures had not been followed diligently; that they hadn't done a proper scrutiny of the candidates, that the serial numbers for candidates hadn't been allotted properly, that the database of members had been given to a few electoral candidates and denied to a few candidates. He expressed his disappointment over the matter and stated that these were his reasons for resigning the post he had held.

The President called the House to order and then explained the issue from the Committee's point of view. He read out appropriate by-laws to justify his stance. 
