From The PRESIDENT'S DESK.....



Dear Members,

The Gems and jewelry sector in India plays a significant role in the Indian economy, contributing around 6-7 per cent of the country's GDP. The government of India has declared the sector as a focus area for export promotion based on its potential for growth and value addition. The government has recently undertaken various measures to promote investments and to upgrade technology and skills to promote brand India in the international market. Prime Minister Modi's 'Make in India' manufacturing initiative has placed a great deal of emphasis on the Gem and Jewellery industry being one of the key thrust sectors for pushing growth and exports. The positive effects of these steps will be seen by the industry in the coming months and years ahead.

Our industry is witnessing changes in consumer preferences, as the westernization of lifestyle is responsible for changes in the buying habits of the consumer. Consumers are demanding new designs and varieties in jewellery, and online jewellery ecommerce site are able to fulfill their changing demands better than the brick and mortar set ups. While gold prices internationally have fallen, the prices in India have not reduced to the same extent as the rupee has gradually slipped against the dollar. Retailers and Wholesalers who are averse to the thought of speculation are forced to do so due to the market circumstances.

Our association is by far the largest organization that represents the interests of the gem and jewellery industry in Karnataka. Over 40 new members have joined our esteemed association over the past year to bring the total number of members to over 1200. We will continue to strive towards the betterment of the industry.

The coming year marks the 75th year of our association. To mark this momentous occasion, we are planning to celebrate the Platinum Jubilee over a 2 day period while having cultural and family events. The 2nd edition of the gold quest treasure hunt was held in the month of August after many requests from members to make this an annual event. Over 200 people participated in this event which fostered camaraderie amongst the members and their family & friends.

A much needed renovation was undertaken and completed to our office premises in Nagarathpet in May after a period of over 10 years.

A XRF gold testing machine was bought by the association which accurately confirms the purity of the sample using non destructive and non intrusive methods. Members can avail of this facility by paying a small fee.

I would like to thank the members of this prestigious association for bestowing on me the chance to serve the industry over the last one year. I would also like to take this opportunity to thank the sponsors for their support.

The proceedings commenced at 10.00 a.m. The master of ceremonies, Ms. Reena D'Souza, requested The President of the Association, Mr. P.V. Mahesh to occupy the chair. She also called upon all the Managing Committee members of the Association on to the dais.

The Hon. Secretary, Mr. Y.S. Ravikumar, read out the notice for the meeting and this was followed by the Invocation.

The Lighting of the Lamp was performed by the Committee Members and a few senior members.

A moments' silence was observed as a mark of respect to the departed members and their families.

The Hon. Secretary Y. S. Ravikumar gave a welcome speech. He said the branding of the Association in the national platform is one endeavor that was in progress.

This was followed by the presidential speech by Mr. P.V. Mahesh. He respectfully acknowledged the contribution made by all the previous Committee Members in the past years of this 73 year old prestigious Association.

The Committee Members and the General Body began discussing the issue on hand. The atmosphere was tense. Committee Member Mr. G.V. Sreedhar and The President Mr. P.V. Mahesh, along with other Committee Members, questioned each other and brought to light the issues involved. The president Mr. P.V. Mahesh called the House to order.

The Committee Member, Mr. B.R. Ajit Kumar took over. He expressed his dissatisfaction and said that the Election procedures had not been followed diligently; that they hadn't done a proper scrutiny of the candidates, that the serial numbers for candidates hadn't been allotted properly, that the database of members had been given to a few electoral candidates and denied to a few candidates. He expressed his disappointment over the matter and stated that these were his reasons for resigning the post he had held.

The President called the House to order and then explained the issue from the Committee's point of view. He read out appropriate by-laws to justify his stance. He explained the procedures and practices that had been followed by the Committee for the past elections and he reiterated that the same had been followed this year too; that the manager was responsible for collecting nomination forms, giving out



numbers to candidates, which is followed by a scrutiny done by the Hon. Secretary. He also stated that the Association shared no database of members with any candidate as nobody had requested so in writing. Arguments by members continued till a point when allegations by both parties came to an end. As there was utter chaos, the President P.V. Mahesh adjourned the meeting for 30 minutes.

After the adjournment, the President requested the members to settle down, so they could take some decisions. He observed that since an election cannot be held in an atmosphere of this nature, he requested the members of the Association to accept his ruling; wherein he proposed that a Five Member Committee be set up to look into the matter impartially and give a report to the Committee within a period of 15 days, that a fresh date for this elections to be decided, the election to be held soon. This was only a postponement of elections. There would be no new entries to contest; the eight members who had already given their names would be the only people to contest in the election. He took a voice vote of the Association members; whereby, a general consent was given.

Voices of dissent were heard in the meeting, as General Body Members hadn't had an opportunity to speak. Following this, speakers came up to the podium and expressed their observations.

Mr. R. Srinivas, who was also contesting the elections, clarified that the database of members contacts was not given to him by the Association as alleged by Mr. B. R. Ajit Kumar earlier, and that he had got it from a web marketing company; that he had sent SMS's to members (and also non-members, totaling about 3000) on his own accord, that JAB office was not responsible for this. (Kannada)

A few members gave their advice and opinions and the meeting continued. After listening to all the speakers, The President announced the names of five members to form a committee (Six names were suggested in case any of them dropped out):

1. Sri Suresh I Dhruv 2. Sri P. Sajjan Raj. 3. Sri Narinder Singh 4. Sri Vinod Hayagriv 5. Sri Eshwar Ganjam 6. Sri Sakala Narasimhulu Chetty.

This was accepted unanimously by the General Body. This was followed by the Agenda of the AGM. The full Committee got onto the dais.
