

The Year that was...... 2015-2016

1. Platinum Jubilee:-

Probably the biggest event of our Association, the Platinum Jubilee celebrations was a roaring success. Held on 2nd October, 2016 at Elaan Convention Hall, it was a whole day affair. Starting from breakfast, there were multiple events, catering to all age groups of the family. The Chief Guest was His Excellency, the Governor of Karnataka, Sri. Vajubhai Vala. He released the Collectors Book and inaugurated the Platinum Plaza, the building acquired by our Association. There were talks from corporate guru Sri Sukhbodananda and Sri Deepak Shinde, which were lapped up by the audience in pin drop silence. The evening had some light programmes – live music by playback singer Vijay Prakash. The music was very entertaining and the audience was dancing to Vijay Prakash's tunes. The evening ended with a fashion show choreographed by Shilpi Choudhury and dinner. There were about 30 stalls displaying jewellery to real estate and other products. The members had a very entertaining day.

2. Purchase of Property:-

Our Association has been trying to buy a commercial property for the last 8 years or so. Our dream finally materialised when we bought a ready commercial complex on a busy main road in Jayanagar. The complex is tenanted and is yielding rents. Spread over a land area of 1200sft, it has 4 floors and has been built just a few years ago.

3. Bundh against Central Excise:-

When the Central Government introduced Excise, the Jewellery industry across the country exploded. They went on a 41 day strike, opposing this new tax. We conducted a series of meetings to discuss Bangalore's stand on the Jewellers Bundh, and also organized a series of protests across the city to create awareness among the jewellers & also the general public.

4.Excise Seminar at Pride Hotel:-

When all the protests across the country went in vain and the government too relented and watered down the Excise Duty, our Association quickly organised a Seminar on Excise Duty. The government, by introducing high manufacturing turnovers for shops to come under the excise net, eliminated 70%-80% of the stores. We organised a seminar by renowned Auditors Ms. Lakshmi Kumaran and Sridharan at Pride Hotel. Attended by only the jewellers who came into the ambit of Excise Duty, it was a very interactive and useful seminar, well received by our fraternity

5.Cricket Tournament:-

JAB, for the first time, conducted a Limited over cricket tournament for its members, aptly called the JAB Cricket League (JCL). Divided into 8 teams of 15 members each, 120 people fought over two weekends at the St. John's Hospital Grounds. The teams were "auctioned" and named after the 8 gems of the Navarathna. The winning team was named the "Diamond" team, who won the Rolling Cup. The response was tremendous and should hopefully be an annual event.

6. Meeting with Legal Metrology Minister:-

The Legal Metrology Department has suddenly introduced a new law, stating that all jewellers should possess an electronic weighing scale which has a 1mg accuracy. Further, it also mentions that the jeweller has to have a separate scale of 1 cent accuracy for weighing diamonds. We met the Minister in charge, Mr. Dinesh Gundu Rao and reasoned with him. We emphasised the fact that 1 mg costs Rs.3 and no customer needs such accuracy. Also, the weighing scales will never have repeatability at 1 mg and then the customer will start doubting the jeweller he has trusted until now. This act will cost the Jewellery industry in Karnataka about Rs.50-Rs.60 crores in new weighing scales and does not serve any purpose. He promised to look into the matter. Unfortunately, the minister has moved onto a different department and the problem lingers on.

7. Collector's Book - "Gems of Karnataka":-

To commemorate the Platinum Jubilee, JAB released a Collector's Book during the Platinum Jubilee Celebrations. This book contains the history of JAB, History of jewellery in Karnataka and pages on the 75 "Gems" of Karnataka — a tribute to the 75 reputed jewellers of Karnataka who have played a valuable part towards the growth of the Jewellery industry in Karnataka. The Book was released by His Excellency, Sri. Vajubhai Vala, the Governor of Karnataka. The 75 "Gems" were also felicitated during the Platinum Jubilee.

Axis bank was offering Gold Metal loans to Jewellers at very nominal rates of interest. A meeting was convened to explain to the jewellers the modalities of this gold loan and advantages of such loans to further enhance business at a nominal cost.

9. Income Disclosure Scheme Meet:-

The Income Disclosure Scheme (IDS) was the new initiative taken up by the central government to harness Black money. Officials from the Income Tax Dept. conducted a seminar to explain the scheme and to educate our members to avail this offer.

10. Swatch Bharat Campaign:-

JAB took up an ambitious campaign to clean up the whole "Pete" area. We involved all the BBMP officials and Corporators from the Pete area. The other associations in the area, namely, The Silk Merchants Association, Electrical Merchants Association, Goldsmith and Silversmith Association, Vishvakarma Association, Hardware Merchants Association, who are all based in this area were also added to this group. Meetings were held with the officials and plans to segregate waste at source (at each store) was planned. Involving the group called "The Ugly Indian", the Chickpet circle was given a huge face lift. Just as we were moving to the next level, the Jewellery fraternity had a new problem in hand, the introduction of Excise Duty. JAB had to divert its full attention to this pressing matter and for the next 40-50 days, was engrossed in this. We lost steam during this issue and never quite regained the momentum we had started with. But the group we started, along with the BBMP officials and the heads of other local Associations remains and even now, when we complain of any civic issue, the BBMP officials quite promptly attend to the problem.

PROCEEDINGS OF THE 41ST ANNUAL GENERAL BODY MEETING

held on the Sunday, October 4th, 2015

St. Joseph's College Auditorium, No. 36, Langford Road, Langford Gardens, Bengaluru - 560 027

The Proceedings Commenced at 10.30 am. The master of ceremonies, Mr. Vivek B Chand, requested all the Directors of the Association to occupy the dais. He then shared the wisdom of lighting the lamp and saying a prayer and invited Ms. Beena Suresh to sing an Invocation song, which she gracefully did. After honoring her, the Directors lit the lamp and formally commenced the meeting.

Mr. Y.S. Ravi Kumar - Hon. Secretary, gave a welcome speech and brought to everyone's notice that the office premises in Nagarathpet was renovated in May 2015. He also mentioned that there was now a new panel of dynamic Appraisers.

He informed that the Association had organized a GST (Goods and Services tax) seminar, and an Internal Auditors meet where they discussed the Income tax and tax related issues. Therefore, 85% of the profits have to be used for Philanthropy or be spent on Capital Expenditure like Buildings. This has to be done within a maximum of 5 years, which the organization has exceeded.

The property zeroed-on is ideal because it's readily built and payments will be accepted completely by cheque.

Details of the Property is as follows:

- Address: No.24, 26th "Ä" Main, 9th Block, Jayanagar, Bengaluru 560 069.
- Dimension: 30 X 40 feet with Built- up area of 5250 Sft.
- Structure: 5 floors: Cellar, Ground, +three upper floors with open terrace on top, OTIS elevator and built around 18 months ago.
- Location: Centrally located on the corner of 26th "A"Main, & 46th cross, Jayanagar 9th Block. Diagonally Opp. Raagi Gudda Arch,
- All floors except the second floor are tenanted.

Total Rent of 1.97 Lakhs Approximately is being currently received.

Total Advances are close to 12 lakhs.

The Plan to Fund the project: Association money available is 3.25 to 3.50 Crores in Bank Fixed Deposits. Out of the reserves they want to use 3 Crores and leave 20 to 25 lacks for contingencies. Therefore, there will be a shortfall of 1.2 Crores.

This is the plan to bridge this gap:

Option-1: There are 1200 members Approx., Each member contributes Rs.10,000/- each and this will bridge the gap.

Option-2: Donation from members. There are 4 categories of members. 1.Diamond donor of 5 lakhs, 2.Platinum Donor of 2.5 lakhs 3.Gold Donor of 1 lakh and 4.Silver donor of 25 Thousand. The Donors names (Except Silver) will be put up in the building.

Option-3: Loan from the Bank.

They have been told that they can get a Loan of 1.25 Crores @ 11.50%Interest. EMI will be 1.76 lakhs Approximately.

Terms of Loan- 10 Years. Processing fee of 1.4 Lakhs

Open house: Suggestion from a member to accept loans from members at bank interest. Another suggestion is to get the tenants vacated and rent it out to the members for a better price.

Mr. R. Srinivas, Hon. Treasurer, explained that the savings for last year was 27 Lakhs. He also explained how it's possible to buy a property and still be in a comfortable position in the coming year regarding income.

Another member suggested that members be invited on another day and be encouraged to make big donations.

There was another visual tour of the building; it was followed by a member advising that the sanction plan for the building needs to be looked into.
