
Members have been wholehearted and magnanimous in supporting all our endeavors and activities.

## The Year that was .....2017-2018

### Exporters meet at The Capitol Hotel:-

Was arranged on 18th November 2017 at 5 pm at The Capitol Hotel, Raj Bhavan Road, Bengaluru - 560 001 to discuss issues and grievances related to exports of Jewellery. JAB Committee Members, Sri. Surya - GJEPC, Bank personnel & 25 Exporter's attended.

### Vikasa 2018:-

An interactive seminar regarding Income Tax, MCX and Police Issues was conducted to educate on Rights and Duties with respect to Government Departments on Friday, 5th January 2018 at Sir M Visvesvaraya Auditorium FKCCI Hall, K G Road. Sri. T. Suneel Kumar, Commissioner of Police was Chief Guest. Committee Members & JAB members attended.

### Meeting with Chickpet Tenants:

Conducted meeting with Chickpet Tenants regarding renewal of rental agreement. Informed them to vacate the premises & planning to renovate the premises & shift our existing JAB office to there. The Committee has appointed an Advocate to issue the legal notices to Chickpet Tenants for the eviction of the premises.

### The India International Jewellery Show (IJS):-

The India International Jewellery Show (IJS) was organized from the 9th August 2018 to 13th August 2018 at NSE Grounds, Goregaon, Mumbai. The Jewellers' Association, Bengaluru in co-ordination with the GJEPC extended its support to our members for the registration and many JAB members attended the show.

### Silver Sub Committee Meeting:-

Silver Sub Committee has conducted several meetings to discuss & fix the uniform Silver rate and other matters pertaining to the trade.

Silver Sub Committee had few meetings with JLR & SGR owners regarding selling less purity of Silver bars. Informed SGR to exchange any low purity silver of their brand to proper 99 silver. Further JAB also took action with JLR by taking back the "99" seal of JLR.

### Meeting with Chickpet Corporator:-

Had a meeting with Chickpet Corporator regarding Social project of PUBLIC TOILET exclusively for LADIES at C.T.Street. JAB has sent an official letter to Joint Commissioner - BBMP & BESCOM requested for the permission for building the Toilet block on CT Street to be funded by JAB.

### Cricket Tournament:-

JAB, for the Second time, conducted a Limited over cricket tournament for its members, aptly called the JAB Cricket League (JCL). Divided into 8 teams of 15 members each, 120 people fought over two weekends at the St. John's Hospital Grounds. The teams were "auctioned" and named after the 8 gems of the Navarathna. ## PROCEEDINGS OF THE 43RD ANNUAL GENERAL BODY MEETING

Conducted on 17th September 2017

St. Joseph's College, No. 36, Langford Road, Langford Gardens, Bengaluru – 560027

The 43rd Annual General Body Meeting of **The Jewellers' Association**, Bengaluru was flagged off on the bright sunny day on the 17th September 2017 at 9:30am. The day commenced with the registration process and handing over a welcome kit to the members and which was followed by the morning breakfast.

The event started with the lighting of the lamp by the current Board Members and was followed by a silent prayer for the departed souls of the members and their kin in the past year, the proceeding was carried out by Mr. Sandeep Saparam.

After this, Hon. Secretary Mr. Ketan S Dhruv welcomed all the members and spoke of how the past year was a tough one with demonetization getting implemented. He also mentioned about the primary focus of the Association between March 2016 to June 2016, which was to stabilize the business post GST. He specified that for this purpose JAB Committee members had a meeting with the Secretarial Committee, GOK Chief Secretary and State Minister Mr. Krishna Byre Gowda to discuss issues of GST and its implementation. The other pressing issue that was worked upon during the year was about the streamlining of the Gold and Silver rates. He also mentioned that the silver Committee took care of the issues with regard to the silver trade. In March there was an interaction with the IT department regarding Pradhan Mantri Gareeb Kalyan Yojana and discussion about the new PMLA law that was going to be implemented also took place. Mr. Ketan S Dhruv concluded his address with a verse from the Gita.

During the year, JAB also organized a very informative and resourceful talk on PMLA -Prevention of Money Laundering Act where, Hon. Secretary Mr. Ketan S Dhruv invited Mr. Shivdas, Mr. Prasanth & Mr. Neeraj from Lakshmi Kumar Shreedhar (Premier Legal Attorneys of India) to give a talk regarding the same. It was a huge success and very helpful for all the members who participated and took keen interest in the event.

The team gave a bird's eye view of the PMLA, its procedures, manners in which the proceedings are conducted, its operations and the precautions people need to take regarding the same. Mr. D.A. Sreeramulu - Ex. Mentor felicitated the three speakers.

Mr. Niranjana S Pamadi took over the proceedings and announced the names of the Export Award Winners who were facilitated by Joint Secretary, Hon. Treasurer, Vice President, Mentor and the President of JAB. The awardees were as follows:

This was followed by the presidential address where the president of JAB Mr. Y.S. Ravi Kumar addressed the gathering. He spoke of his 12 year Association with JAB and how he started off as a director, then became Joint Secretary for 6 years followed by Hon. Secretary for 4 years and today is now serving as the youngest President of JAB.



Mr. Y S Ravi Kumar in his speech stated that, It was his dream to see JAB being recognized across the globe for its achievements and succeed as a trade body. He also thanked all members & the board for their support and concluded with a powerful leadership quote by Dr. APJ Abdul Kalam.

The President then read the conformation of the 42nd AGM proceedings held on 6th November 2016. He then requested the General Body to go through last year's proceedings and confirm it so that it could be passed.

The Proceedings of the 42nd AGM were confirmed and passed by the General Body:

**Proposed by:** Mr. P Nagaraja - M/s. TAP & Co.

**Seconded by:** Mr. B.H Ramachandra - M/s. Geetha Jewellers

**Approval of statement of accounts of 2016 - 2017:-**

After the President's address, Hon. Treasurer Mr. R Srinivas presented the accounts. He stated that, The Jewellers Association of Bangalore which was a registered body under society act, enjoyed a tax free status all these years. He also mentioned that some of the agencies misused the tax free status. Hence the government started scrutinizing the accounts and as a fallout, JAB's accounts were also scrutinized for the period 2013 -14 & 2014-15 for no apparent wrong doings by JAB.

Both years unfortunately the assessing officers assessed that JAB's income would now be taxable (income here refers to rental income, appraised income, FDs and sponsorship) - out of these the IT officer has considered the sponsorship and appraisal activities as commercial activities and demanded tax from the association.

Both years put together the amount was about 26 lakhs. As a result industry experts were consulted and were of the opinion that JAB shouldn't be taxed. Hence with the help of top expert lawyer in the city Mr. Shankar an appeal has been made to the assessments made by the IT department and the hope is that JAB's contention will be upheld and would continue as a tax free status.

Mr. R.Srinivas also mentioned that "a note has been made in the statement of accounts this year and have shown the amount made by the Income Tax dept., and to go and appeal - 15% of the demand had to be paid (i.e. about 4 lakhs) as appeal amount".

He also mentioned that In the year 2016 a property was purchased by JAB with the consent and approval of the General Body in Jayanagar which was named as 'Platinum Plaza'. For this, JAB auditors have an opinion that, as money used in the Fixed Deposits were used to purchase this property, this may cause income tax on JAB's income but the consulting experts believe JAB won't be taxed and this will be pursued post AGM.

At this junction there were a few queries that were asked by the Hon. Members of JAB which were answered by committee members after which the accounts of the previous year was passed. The questions that were asked and their respective reply are as follows:

1. Mr. B.R. Ashok Kumar from M/s. Geetha Jewellers asked about the Unsecured loans that JAB had, its position and how much JAB had paid back?

Hon. Treasurer Mr. R Srinivas informed that, JAB had to borrowed Rs.40 Lakhs, the unsecured loans to purchase property from Bangalore Refinery Pvt. Ltd. Out of which 10 lakhs was repaid. Out of the rental proceeds, we should be able to repay another 20 lakhs.

The President added that 3 floors were vacant in the property that was purchased. And also that two days prior to the AGM the 2nd floor was finalized. He also said that the advance had to be obtained and rent will go towards clearing the loan (2lakhs approx.)

Mr. D.V. Ramesh said that earlier the suggestion was made that whatever sponsorship JAB would take will be only in the form of donations and not in the form of sponsorship as it unnecessarily attracts income tax.

For this, the President Mr. Y.S. Ravi Kumar informed that, Sponsors would not want to give the amount as donation as they can't account it as business expenditure.

**The General body passed approval of accounts for the year 2016-17:**

**Proposed by:** Mr. D.V. Ramesh - M/s. Davanam Jewellers Pvt. Ltd.

**Seconded by:** Mr. T.S. Shashi Kumar - M/s. Vijaya jewellers, Tumkur

**Selection of Auditors:**

Next on the Agenda was the selection of one auditor and two local auditors.

Mr. R. Srinivas called to give the reason for change of auditor, Mr. Reddappa retiring from practice.

**M/s. Ramraj & Co** was identified to be auditors as they were already synced in with the consultant for appeal. He also said that Mr. N S Arun Kumar's (Internal Auditor) remuneration would be increased as per standards as against what was paid earlier which was much lower. Mr. R. Srinivas also mentioned that the remuneration will be mutually agreed by the board and auditors.

For this, a question was raised by Mr. Manjunath of M/s. Ekadanta Jewellers asked, who takes a decision regarding the remuneration aspect and weather it was the AGM or managing committee?

Hon. Treasurer Mr. R. Srinivas informed that, the AGM approves a budget of 40000/- as audit fees & within that the board would discuss with the auditors and will fix the amount.

Question raised by Mr. Manjunath: The common practice was that the auditor's remuneration discussed and fixed in the AGM now the Managing Committee

Response: The President Mr. Y.S. Ravikumar informed that, earlier the AGM never fixed the remuneration & they only approved the budget.

Mr. Manjunath also specified that it was not possible to approve the budget without knowing the amount to be paid, for which the President and Hon. Treasurer said that the Rs.40,000 amount was not fixed and was only an estimate and that they would still negotiate to reduce the said amount. And also that, this amount is not exclusively for the auditors fees alone but also includes the remuneration given to the internal auditors as well.

It was mentioned that this is for external auditors who are doing the tax audit for JAB. The Internal account was to be maintained by N.S. Arun Kumar who has agreed to continue.

Hon. Treasurer Mr. R. Srinivas mentioned that, Auditor Mr. N.S. Arun Kumar would prepare the statement of accounts on every month and once in a year prepares the Balance Sheet based on that auditing was to be done by the external auditor.

An honorable member asked how much amount was paid to the auditors for which it was replied that in the previous year Rs.5000/- was paid to Mr. Redappa who is a Chartered Accountant and Rs. 21,600/- was paid to the internal auditors. It was also mentioned that Rs. 40,000 included the amount for internal auditors and also it was a tentative figure which would include the fees for M/s. N.Ramraj and Co - Chartered Accountant.

**The General body appointed the new auditor M/s. Ramaraju & Co:**

**Proposed by:** Mr. Manjunath - M/s. Ekadantha Jewellers

**Seconded by:** Mr. Prashanth J Mehta - M/s. Rajesh exports Limited



Later the President offered any of the honorable members to take up the positions of the local auditors.

The Previous year auditors were Mr. Rama Sanjeeva - M/s. Shantala Jewellers & Mr. B.R. Ashok Kumar - M/s. Geetha Jewellers. Both of them were felicitated.

**The General body appointed the Internal Auditors for the ensuing year, as follows:-**

Mr. Venu - M/s. Jayalaxmi & Co

Mr. Raghu - M/s. Raghu Jewellers

Approval of budget for the year 2017 - 18

Questions raised by General Body were as follows:-

1. Question - How much was the staff salary last year?

Hon. Treasurer clarified that, Rs.11,00,000( Eleven Lakhs) was spent last year + increment plans to take on new staff. Hence the proposed amount is 14 lakhs.

2. Question - Rs. 5 Laksh - Clarify on the ERP and mobile app implemented?

The president clarified that the ERP solution was the need of the hour for trying to bring the entire jewellery fraternity on one platform (online and mobile). This would also help to do internal business within the trade at B2B platform and also helps the fraternity to know each other better. The advantages of the App included in the ERP implementation would also help to cleanse the database of JAB and link it to Aadhar. It would also facilitate in taking the biometric database of all members so that we could help ease various issues and also help in the registration and voting process during the upcoming AGM's.

**The General body passed approval of budget for the year 2017-18.**

Mr. B.R. Ashok Kumar from M/s. Geetha Jewellers applauded the appraisers who put in a lot of effort to ensure the process of exports was smooth and was not hampered and ensured that the goods were exported across the border on time.

**Honoring the staff of JAB:**

The Staffs were honored by the President Mr. Y.S. Ravikumar:

Mr. Venugopal.R - Manager, Mr. T. Venkataramana, Mr. B. Venkatesh, Mr. Naresha & Mr. Kiran Kumar K.R

**Subject matter received in writing:**

A written letter was received from Mr. B.R. Ashok Kumar from M/s. Geetha Jewellers about points on membership. Mr. B.R. Ashok Kumar stated that Mr. S. Venkatesh Babu was appointed as a mentor approved by all, however this year he decided to join the board and hence a vacuum now created and would like to fill that space.



Mr. Manjunath from M/s. Ekadanta Jewellers raised a query regarding the necessity of a mentor. He suggested instead, to have an advisory committee of different persons in it rather than having a single person as mentor.

For this the president of JAB responded by stating that the bylaws of JAB was silent on the mentor issue and that the committee has been seeking advice from the seniors of the fraternity before taking any decision on important and significant matters. To form the Advisory Committee, he would leave it to the next Committee to take the decision & seek approval in the next AGM.

Mr. G.V. Sreedhar - Ex. President of JAB gave a talk on PMLA and its process, FIMF (Financial Institutions Task Force), Hallmarking and its challenges and requested JAB to follow compliance.

Mr. Sanjay from M/s. Sri Krishna Hallmark spoke of the UDI (Unique Device Identification) scheme being in total protection of jewellers, customers and consumers.

### **Election of the Management Committee for the year 2017-18**

The election procedure of "The Election of Management Committee for 2017 - 2018 was the last on the agenda.

Mr. S. Venkatesh Babu did the honors of felicitating outgoing director Mr. Sandeep Saparam and Mr. N. Praveen Kumar.

Mr. R. Srinivas - Hon. Treasurer and Mr. Y.S. Nagaraj - Vice President were also felicitated.

Mr. R. Srinivas and Mr. Y.S. Nagaraj would be re-contesting Elections.

During this process a query was raised about the position of the Mentor of JAB as the present mentor Mr. S Venkatesh Babu would be contesting in the Committee Elections. For this the president Mr. Y.S. Ravikumar informed that Mr. S. Venkatesh Babu had already submitted his resignation letter as mentor of JAB on the 15th of September 2017 itself but it was yet to be approved. Mr. Y.S. Ravikumar then requested the general body to approve Mr. S. Venkatesh Babu's request to contest in the committee elections for which the general body gladly approved for the same.

Later, an honorable member suggested to drop the post of the mentor. He also suggested to honor the people who are doing excellent work among members, for which President Mr. Y.S. Ravikumar informed that, the Committee would look into it and decide whom to honor and the reasons behind honoring such eminent persons.

From here on Mr. Vivek B Chand took over the proceedings and stated that any vibrant association should have elections and this time there were a total of 7 contestants contending in the elections.

He explained the election process, the formalities and the procedures to be followed in detail. Mr. Vivek also explained that in the previous years the voter ID machines were obtained from ECIC but unfortunately couldn't get the voter machines this year from the ECIC.

Therefore, the General body approved rupees 5 lakhs for the software development module in which, one of the package was the election process. It was assured that it was a fool proof process and that unless a member registers to come for the meeting he will not be able to get into the election process and hence won't be able to vote.

### **The Election Process Commencement:**

Candidates were in order of their serial numbers in alphabetical order. Each candidate got 2 minutes to speak as to why the general body needs to vote for them.

All seven candidates introduced themselves in the following order:

2. Mr. Nagaraj Y.S of M/s. Sunrise Jewellers
3. Mr. Prashant J Mehta of M/s. Rajesh Exports Limited
4. Mr. Raghu Prasad K.C of M/s. KCR Jewellers



5. Mr. Srinivas R of M/s. Sharadha Silver Chain Factory
6. Mr. Srinivasan R S of M/s. R S Srinivasan Jewellers
7. Mr. Venkatesh Babu S of M/s. Chetana Jewellers

The process of voting and the other formalities were explained to the general body in detail for the smooth and transparent process of voting to take place.

General body then appointed Election Officers for the smooth functioning of the Election.

Mr. V.M. Manjunath from M/s. Ekadanta Jewellers & Mr. T.N. Sandeep from M/s. TAP & Co were appointed as Election Officers.

Mr. K.S. Kedarnath from M/s. Jewels Garden was invited to overlook the election process. The election process commenced along with lunch taking place simultaneously.

The entire election process went on very smoothly and when it was time to announce the results, the election officers called on stage all the 7 contestants. The election officers then stated that the voting went on well and successful, however surprisingly among the 7 contestants there was a tie between 2 contestants.

As there was a tie between the two contestants, the general body after weighing the various options presented, decided unanimously to draw chits between the 2 contestants. A total of 10 chits were drawn, 5 each for the 2 contestants namely between Mr. Prashant J Mehta from Rajesh Exports and Mr. Y.S. Nagaraj from M/s Sunrise Jewellers.

Election Officers T.N. Sandeep and V.M. Manjunath were the only 2 persons who were allowed to conduct the tie process.

The process of selection via picking the candidate through picking a chit commenced and a lady present at the venue was asked to pick a chit and hand it over to the election officer. Mr. Prashanth J Mehtas name was picked and thus the election officer announced him as the winner.

Mr. T.N. Sandeep & Mr. V.M Manjunath being the Election Officers, announced the grand results as follows:

**The total number of members who casted their votes were 379.**

The highest position was secured by Sri. S. Venkatesh Babu, with 333 Votes.

The second position was secured by Sri. R. Srinivas, with 271 Votes.

The third position was secured by Sri. Ajit Gupta D.S, 251 Votes.

The fourth position was a tie between Mr. Y.S. Nagaraj & Mr. Prashanth J Mehta who secured 223 Votes each, and by Chit selection Mr. Prashanth J Mehta was declared as winner.

The winners were congratulated.

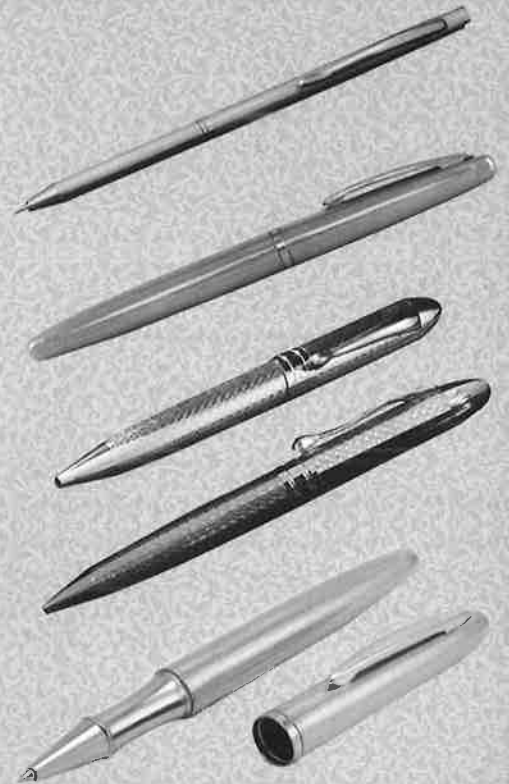
