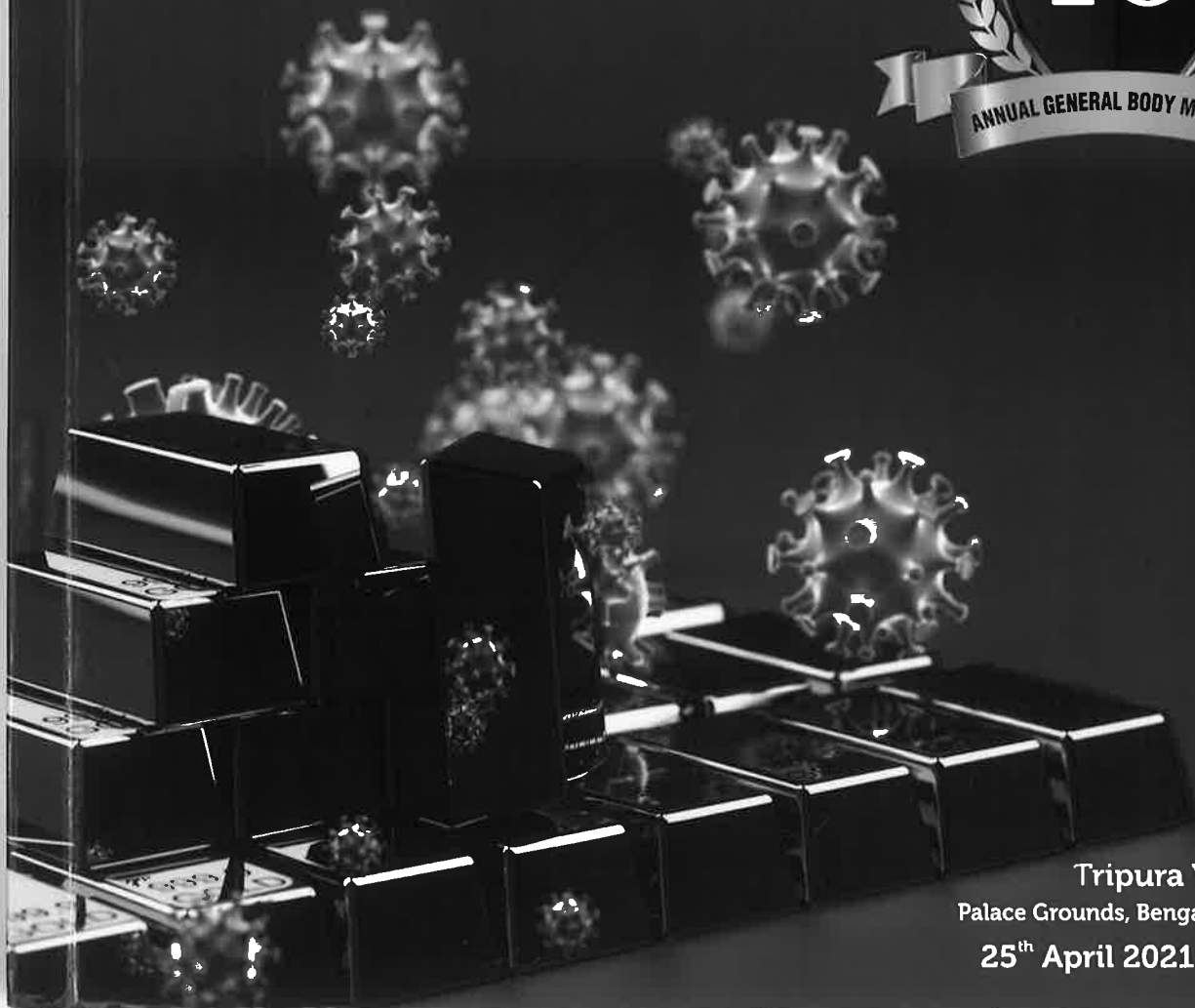

Bullion Meeting at JAB Office: Bullion meeting called by N. Vidya Sagar & held at JAB Office regarding Gold bullion related issues. More than 40 bullion dealers attended.

THE PROCEEDINGS OF THE 45TH ANNUAL GENERAL BODY MEETING OF THE JEWELLERS' ASSOCIATION, BANGALURU

Conducted on 22nd September 2019

Taj Yeshwanthpur, No. 2275, Tumkur Road, Yeshwanthpur, Bengaluru- 560 022.

The gathering was warmly greeted by Sri Ashok Rathod. He welcomed everyone cordially and announced the itinerary for the day. The management committee members lit the lamp.

All the management committee members were introduced and invited on the dais.

Mr. Harinath Pobbathi was invited upon stage to present the invocation song. He invoked the blessings of Lord Ganesha through his reverberating hymn. He was thanked and honored by the president of JAB.

Silent Prayer for the departed souls list was read by Sri Ajit Gupta. D.S., management committee member, JAB

The Annual General Body Meeting 2020 was called to order by the President.

President's thoughts:

The President mused that this is unfortunately the most challenging period of their lives as the rates are going up whereas the businesses are coming down. More so with the governmental policies assuming that theirs is a rich man's luxury product and disregarding the fact that it's a poor man's asset. "In the recent meeting where all the financial sectors were invited, in order to boost the financial sector. Sadly, here also a step motherly treatment was given to our sector. It was asserted that our jewelry sector is a non-essential and non-productive commodity and it is draining away all the precious foreign exchange. Hence, we cannot expect much from the government in the benefit of our trade." Despite this, our national bodies are doing their best in making them understand the realities and are also giving them some proposals of other alternatives like gold mortgage and scheme he alerted.

He continued that "secondly, the cleansing of the silver trade was taken up once again with newer tools." A special appreciation of Mr. R.Srinivas and the silver trade committee were made for their contribution. The President also acknowledged that wrt the Kodagu project, they couldn't put the funds to immediate use but because of the fund they had, they would do something concrete i.e., the Anganwadi project.

"A year that was" presentation by Hon. Secretary:

1. Seminar on diamond grading and CVD's was conducted by Mr. Ashok Rathod.
2. Talk from Mr. Hairsh, advocate from DNS Law regarding unregulated scheme ordinance which is now a law. It was learnt that one cannot take deposits on which one can give interest / incentives to the customers. This can happen only on some businesses and presently there is no clarity on whether the schemes which are run are called as deposits or classified or not. As a trade body what can be done is one can take advances from the customers and give discounts.
3. Seminar on BIS hallmarking and gold assay. Members were explained what is gold assaying and what are the nitty-gritties of BIS Hallmarking. Speakers: Mr. Rajkumar and Dr. Karrey
4. Silent March to protest Pulwama Attack attended by more than 5000 people. Within a day or two of the attack, the association called for this march and it was quite successful.
5. Meeting to discuss Bullion related issues chaired by Mr. N Vidyasagar. Main issues discussed were duplicate bars, contamination in gold and issues of assaying.
6. Seminar on TDS held by Mr. Swapna Das, the Commissioner of Income Tax. It was learnt how one has to be very careful with the cash transactions.



7. Seminar by MCX on hedging techniques for Bullion. It was discussed on how one can protect oneself from the variation of rates, customs duties, etc.
8. JAB Cricket league couldn't be conducted.
9. Meeting with the CEO of the World Gold Council regarding policy issues concerning the gold industry. A lot of feedback was given to them but unfortunately nothing has been implemented.
10. Meeting conducted by FKCCI for the tax terror. A suggestion was given that the association needs to give a presentation and the grievances and changes requested will be conveyed to the government.
11. Mr. Rajiv Garg from GJCSI had visited. He educated the board regarding skill development and prior learning. The participation from the members was very low. A request was made to help the workers get registered with this program. Besides getting some monetary benefit, some data can be collected as to how many people are actually employed. It will help in giving nearly actual numbers to the government.
12. Silver Committee - The biggest achievement of the committee was the new silver 999 program. Various meetings were conducted regarding this and a new agreement was formed which was more legally binding on the refiners. Within the new agreement, after the signing, inspections were done. It was affirmed that if the refinery was found to be suitable and had reasonable quality assurance step, then only it qualified for the program. Right now there are six refiners in this particular program:
 - J P Corporation
 - SVR Refinery
 - Jwala Jyothi Refinery
 - Vishal Sagar Bullion
 - Jai Ganesh Refinery and
 - Sri Ganesh Refinery.
13. Salient points of the new silver seal:
 - The seal will be issued every year. So, it will be known when it is manufactured. They will have a code for the refinery that would've refined the silver or melted the silver. There will be traceability to the person who has made the product.
 - JAB has reduced the assaying charges for silver and all the traders and the bullion are requested to check the silver at the JAB office. Also the silver committee will regularly take samples from the market and monitor it. If any issue is found, the refiner will be confronted and seals will be withdrawn.

A report was presented by the treasurer on The Kodagu Relief Fund. He recollected that two years ago, when nature threw a fury at Kodagu, the JAB members started a collection drive in order to make whatever contribution they could. With the generous contribution of the members fifteen plus lakh rupees was collected. Utilization of the fund couldn't be made with immediate effect as the government was extremely slow in response. There were no roads and the bridges had fallen. There was no accessibility. The government took a lot of time in restoring accessibility to Kodagu. Post this, the association stepped in. They were very clear from the beginning that some infrastructure will be provided to the affected people.

After a year of the devastation, they visited Kodagu and with the help of Mr. Muliya Keshav Prasad, the local jeweler and member of JAB and the Rotary District, they were taken around and shown the affected areas. A few projects were shortlisted and after two or three refinements, it was very disappointing to know that the government wasn't ready to collaborate with such organizations. He said that they have come forward to collaborate only recently. Hence, the project "The Anganwadi @ housing clusters" has been shortlisted. A few hundreds of houses that were lost were relocated in about five to six clusters (made by the government). Each cluster having 80 to 150 houses. It was announced that the houses were almost in completion stage. All the

houses built there are for the workers who have lost their houses. Anganwadi is required in such situations. There will be one Anganwadi in each cluster. The government will allot the land. The building and the compound wall will be built with the funds collected by the association he said. Some garden and play equipment will also be provided along with this. The cost of the same is estimated to about Rs. 18,00,000/- including the play equipment. An MOU will be signed shortly with the government. JAB and the Kodagu Rotary will be the local implementation partners. It will be a tripartite agreement and very soon this project will begin said the treasurer.

The Annual General Body Meeting 2020 was called to order by the President.

Statement of Accounts was put up for the approval and consideration of **General Body.**

Audience #1: "Last year, the amount collected was Rs. 20,00,000 and the expenditure incurred to conduct the AGM was Rs. 26,00,000/- The treasurer at his discretion could've saved about Rs. 7,00,000/-"

President: "Due to the election meeting held the previous year, over 1000 people had attended although the expectation was of about 800 to 900 people. Hence, five to six lakhs extra was spent. Sometimes, there is a loss and at other times there will be a gain but the motive of the association is always to have zero expenditure for the association."

Treasurer: "The additional amount saved the previous year was four lakh thirty thousand odd rupees. Earlier to that also, it was about four lakh two thousand rupees. That is despite spending extra last year, there was a surplus. We have always tried to save this surplus year after year."

Audience #2: "As mentioned in page no. 35 of the annual magazine, the appraisal charges received was Rs. 16,02,500/- whereas the receivable appraisal charge is Rs. 1,71,115/- Kindly explain."

Treasurer: "The due amount will have got credited in the subsequent month and it was Rs. 1,71,000/- last year and about two lakhs this year."

Audience #3: "Is there any revision in the membership fees? Suppose there was a revision, it would've benefitted in clearing off unsecured loans."

President: "We plan to revise it after the AGM. Immediately after the AGM, it will increase to Rs. 25,000/-"

Audience #4: "On page no. 35, it shows that the amount collected this year is 2500/- but I suppose it is deteriorating year after year. Also, when we have big exporters, why isn't it increasing?"

Mr. Prashanth J Mehta: "The government doesn't want the export to happen from the DTA sector. They want all these exporters to move to SVZ units as there it is easy to monitor and control the data. In DTA sector, the scheme is getting misused. So, it is compulsory to move it to SVZ. There in SVZ, the norm is that the only monitoring agent will be the government of India."

Audience #5: "The previous year, there was an issue about income tax compliance."

Treasurer: "The demand started in 2012-13 and has continued until now. There was a demand for Rs. 38,00,000/- and So far a deposit of Rs. 29,00,000/- has been made. We are quite confident that we will win the case. Although it is four years already and may go on for another four years."

Audience #6: "What was the income and expenditure made out of JCL?"

"It wasn't played the previous year."

Treasurer: "Loan was availed from Bangalore refinery in order to build the platinum plaza at 9% rate of interest. Only ten lakhs of which is remaining which also will be repaid by 31st March 2020. The entire loan can be repaid shortly looking at the income that we are receiving."



2018-19 accounts were passed.

Selection of the local auditors: The following two members volunteered and the general body approved them as Local Auditors.

Approval of the budget 2019-20:

In 2018-19, the budgeted expenditure was 23,60,800/- where as the actual expenses was only 18,39,656/-. The proposed budget for 2019-20 is Rs. 21,61,800/-

Audience: “The staff salary is increased by Rs. 61,000/- this year. What is the procedure adopted to give the increment in the staff salary? Rs. 14,04,000/- was proposed the previous year. Actual expenditure is Rs. 12,00,650/- Estimated budget for 2019-2020 is Rs. 12,61,000/- Is there a fixed method of increasing?”

President: “We are looking forward to recruit yet another staff. If an efficient candidate is found, we would like to recruit. Hence, some additional budget has been approved. Also, depending on the work efficiency, care has been taken so far to ensure the increments have been made to deserving staff members.”

Suggestion from the member: “If any incentives are given to the staff members, they will work more enthusiastically. This was received appreciatively.”

Proposed by: Mr. B.H. Ramachandra - Geetha Jewellers

Seconded by: Mr. T.R. Satyanarayana Setty - Gayathri Jewellers

Member: 1. Notifications such as governmental policies and GJC may be shared with the members either on Whatsapp or any other media in order to appraise the members on the latest notifications. Except for the gold rates no other information is being communicated as of now.

Secretary: KetanS Dhruvas mentioning about the unregulated deposit scheme. Regarding this, the government has provided a clarification that any amount taken during the course of business is treated as advance against the future supply. Most of the restrictions have been levied only to the companies. It is still a grey area for the firms.

President: As everyone knows, the unregulated deposit scheme was a burning issue. We have dealt it in the best possible way. The reason why this was not yet brought to the notice of the members is because there was no proper authority or set up appointed for the banning of the regulation act. Now we are affiliated to the GJC. Also, we have clarity now. All the notifications will be shared with the members henceforth.

Member: The government or the GJEPC (Gem and Jewelry Export Promotion Council) is now announcing domestic council. Our association is now eligible to be a member of that domestic council. Once we become the members of that council, we will have direct interaction with the finance and the commerce ministry. Kindly take this into consideration.

Approval was taken for this membership from the general body. All members gave assent.

Another suggestion from the member: The “GNANA JHOTHI” project will be more successful and useful to people if it is held on a Sunday instead of a Monday.



Subject matter received in writing:

Mr. Ketan S Dhruv: Received from Astalakshmi Jewelers. A lot of impure gold is being sold as fake gold. It's the powder mixed gold like OCM, ruthenium, etc. The problem that the wholesalers are facing is that after polishing the entire product is lost. This material coming into the market needs to be avoided, as when this material is used in the jewelry, the finishing will not be achieved and the material will be lost. How to avoid this situation?

Member: How to identify it? Is there any procedure to identify this powder mix gold? Suppose the gold doesn't seem suspicious, how to identify or test?

Mr. Ketan S Dhruv: The procedure is to dissolve the entire gold. We can't figure it out plainly by looking at it. Also, one bag out of the entire lot may have an adulteration. At an individual level, this has to be blacklisted with the bullion dealers.

Mr. S. Venkatesh Babu, President: The buyer should be aware. The supplier should be warned when such a lot comes.

Member: What's being done for silver can be done for gold also like three warnings to the supplier and blacklist that supplier from the association after that.

Prashanth J Mehta: Serious legal action is being considered in this regard. The members are requested to give in writing about the source so that action can be taken.

Member 1: "Inkling happens to us sometimes but we don't get vocal about it. The luncheon was arranged very well but the seating arrangement wasn't appropriate. The seats should be distanced well. Secondly, the program in the first session was a little elaborate; it can be made a little concise so that more time is spent on the AGM. Thirdly, the office bearers have agreed to consider cost-cutting. We are glad to know that we have saved two lakh rupees this time as the election was not conducted. However, whom should this credit go to? It should go to the ones who withdrew." A gesture of gratitude was shown to Mr. Praveen and Mr. Arun Jain for withdrawing from the election.

Member 2: The speaker this morning taught us how to reinvent the business. I had suggested a few things the previous year like organize programs, inspire members, welcome youth to the industry, etc. It was done today and throughout the year this was done, appreciate it. WRT the fake gold topic, I experienced this once myself. As already suggested kindly, introduce the committee for this purpose and get it monitored and regulated as this is spiraling.

Member 3: I was deeply hurt during the Gnanjyothi program as I was very keen on attending and getting ennobled by the wisdom shared but I can't afford to attend it leaving my store on a weekday evening. Kindly arrange in a more organized manner and with transport facility. Arrange at least 4 such programs in a year.

President: As there have been mixed views about the above, we are experimenting and will definitely consider.

Member 4: (Sri. Sampangiram- SK Ayodyaram Setty and Sons, Tumkur): I have been suggesting co-opting from the last 5 general body meetings. Kindly don't ignore this. Also, please arrange people from various headquarters together and provide meetings on taxation and other important issues.

President: My sincere request in this present general body meeting to co-opt you immediately.

Member 5: We had requested to arrange for a shut down on 15th August.

President: If the general body co-operates, we will do three not one; on Independence Day, Kannada Rajyotsava and Republic Day. Let's leave it to the discretion of the members.

Member 6: S K Ramasetty Jewelers: The issue for outsiders is attending any of these programs. Kindly arrange at least one out of four such programs outside Bengaluru.

This is done already by the Karnataka Federation and cannot be done by JAB as there will be a clash with the federation. However, this can be conveyed to the federation.

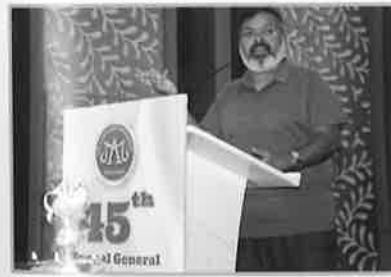

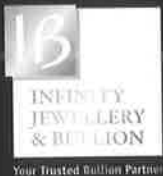
