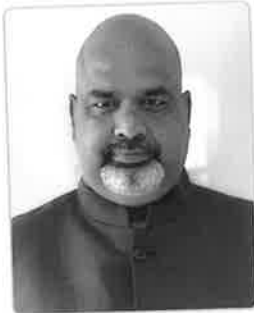

The Year that was2021-22

The year started with lot of challenges. We were in the second covid wave and we had just completed our first virtual AGM in May 2021. With lock down relevant we started our work.

1. The deadline for mandatory hallmarking was approaching fast. We conducted two virtual seminars to educate the members. Also we along with other associations filed a writ in Karnataka high court against the illegal provisions of the Hallmarking Act / rules. The case is still under progress. We also took part in the one day strike against the provision of Hallmarking and submitted memorandum to MPs and MLAs on the issue. With the joint effort of associations across India we were able to get many in the rules which made it implementable. Relaxation in most districts without infrastructure, more karatages, non-transmission of HUID, relaxation for exhibition, relaxation for polki and Jadau., etc.,
2. A virtual seminar was done by a prominent Chartered Accountants to educate the members regarding the changes in TDS and TCS provisions. It was a first in the Industry.
3. A massive vaccination drive was undertaken by JAB with the help of **Mr. Chetan Kumar Mehta, Director** and we have given **5000 (Five Thousand)** doses to the karigars.
4. The board attended a meeting of the Jewellery associations of Karnataka to discuss the various issues that we need to work together.
5. The new trade notice from custom caused many issue in exports. JAB worked with the customs and got it streamlined.
6. We launched the second edition of the B2B show SJS in August 2021. This was much better than the previous show and had a better layout, more road shows and also hosted buyers from many parts of India. Most participant'sachieved great sales in the show. Also it was inaugurated by the **Hon. Chief Minister Sri. Basavaraj Bommai**. Looking at the success grandeur of the show we were able to convince him for a jewellery park in Bengaluru which he obliged and announced at the show.
7. We also assisted GJEPC in organizing the IIJS premier in Bangalore. We assisted them in road shows and other arrangements. Also we helped ensure to get reduced admission fee for our members. GJEPC also provided a stall for JAB at IIJS premier. This too helped us in getting traction for our cause of the jewellery park.
8. In September 2021, there was a joint meeting with VTPC, Chief Secretary, Industry secretary, GJPEC and JAB regarding the jewellery park. JAB explained the basic outline that would be required at the park. VTPC was appointed to study the feasibility of the proposal. JAB assisted VTPC regarding the same by site visits, interview, discussion etc. After study of the feasibility report it was decided to allocate about 15 acres of land to the park. Also an announcement of a mega Jewellery park was made in the state budget.



9. We had launched a B2C show in December 2021, but had to be delayed due to COVID, to Jan 2022, which was further delayed. The first edition of JSI (Jewellery show of India) conducted in April 2022 at Tripura vasini.
10. We had also launched city marathon called "Run for Gold". This was targeted at the younger generations with the view to bring their interest in gold and jewellery. However due to covid we had to postpone and later cancel the event.
11. We had the 3rd Edition of the SJS show. This was better organized than the second edition. We had more options for food for the exhibitors and visitors. There was a fashion show as well. Also the hospitality was very well streamlined. In fact many hosted visitors mentioned they have not seen such a well-organized hospitality in the industry.
12. All the floors of the Platinum Plaza are on rent.
13. **Legal issues:-**
 - a. We have filed an eviction case against the tenants of the Chickpet property.
 - b. We have received an eviction notice from Muzaraidepartment regarding our current office premise. We have approached the court for the same.
 - c. We have few Income tax notices under litigation.
14. The previous vendor who was given the work of completing the software for registration and election could not implement the solution. Hence a new solution was developed with a different vendor. The framework of the solution is such that it can be further developed to provide more services to our members.
15. We had collected funds for flood relief for Kodagu in 2018. It was decided to be used for building a Monsoon Shelter. After lot of follow up we were able to get the land allocated for the project. The **Bhoomi Pooja** has been performed and construction work has started.
16. The CCB has arrested few person who were making fake gold bars. JAB has assisted where possible. We have also warned the members of such activity and released a circular regarding the cheating that is happening with respect to the unregulated assaying and refining centres. We hope that members follow it for their own safety.

The 46th AGM yet first of its kind as it was a virtual meeting was grandly opened by Mr. Y S Ravi Kumar. Welcoming everybody, he took the opportunity to introduce the Managing Committee members.

Mr. M N Prasad was called upon to read the names of deceased family members. Meeting observed minutes of silence in honor of departed souls.

Mr. D S Ajith Gupta, the outgoing director of JAB expressed his immense appreciation of the JAB staff and warmly thanked everyone for the support during his tenure.

The Presidential speech was delivered by Mr. N Vidya Sagar, President, JAB.

Mr. President commenced his speech by iterating that nothing is bigger than nature and wished that such a pandemic should never repeat in the course of history. He believes that every piece of jewellery tells a story, and this prestigious industry is made of many such stories or pieces of jewellery. He feels proud that the JAB fraternity extended a very good support to the Karigars during this pandemic. Continuous efforts have been made from the organization to bring up the Karigars and one such effort was discussion with the government of Karnataka including the Minister of Minerals, Mr. Murugesh Nirani and post discussion, he initiated the launch of the Gold Coins under the Govt. of Karnataka Mint. Next up, the conduction of JAB Cricket League JCL, cricketing talents were honored and recognized during the league.

Mr. Ketan S Dhruv, Hon. Secretary presented the report of the activities of 2020:

1. Donations were collected for COVID from the members.
2. Based on the need of the hour, PPE kits were donated to the hospitals, masks and sanitizers to the police stations, groceries for the Karigars, and sent out SOP's for operations.
3. Distributed medicines for the ill and suffering and set up help line to guide them
4. Tried to lift the lockdowns in the city area which was longer than the other areas in the city and implemented the odd and even system in the city area as per legal guidelines.
5. Held a zoom seminar to understand the challenges and the packages required that could be adopted from the government.
6. Conducted the B2B Jewellery show at Tripura Vasavi in January inaugurated by the Deputy Chief Minister
7. Meets with local MLA's and MP's and chalked out plans to minimize the destruction in the grey areas and came up with alternate plans for the businesses to go on.
8. Proposal for Jewellery Park in Karnataka was put forth.
9. Meeting with the ADC to sort out the customs related valuation of exports.
10. The 15,50,000/- fund collected towards the Kodagu relief fund was worked upon.
11. The 3rd edition of JCL was conducted in March 2021.
12. JAB arranged for private patrolling of bazaar areas during lock down, to safe guard members establishment.

The president called the meeting to order:

The minutes that were already circulated among the members and was proposed by: Mr. Bhavesh Mehta of M/s. Rajesh Jewells and seconded by: Mr. Moulik A Shah of Ashok Dalpatlal & Sons. Minutes were approved.

The Accounts were presented by the treasurer Mr. Srinivas R:

- Provisional accounts for the year 2020-2021
- 1. Audited accounts for 2019-2020
- 2. A surplus of about 15,50,000/- was made in the said year.
- Provisional Account Statement of the Balance sheet for the year 2019-2021 which is unaudited.

1. Query: Why hasn't the accounts been audited

Response: It is because it is only 50 days yet since the year end.

2. Query: Why are the JCL expenses more?

Response: The earlier year, the ground was booked but couldn't be conducted whereas its expense was about a lakh rupee. The current year, the expense is about 3,50,000/-

3. Query: The fund could've been utilized in a better manner than spending on JCL, why was cricket given so much importance during the pandemic?

Response: A surplus of 1,00,000/- has been made due to the cricket league.



4. Query: Who are the exporters who have kept the payment pending and has it been realized subsequently?

Response: A credit period of 15 to 20 days is allowed for pending payments. Hence, a balance of 1,50,000/- is shown. The whole amount has been realized in the subsequent month.

- It was announced that a surplus of 52,100/- is made in the current year. However, the reasons being that a. the income was less due to the COVID pandemic, b. the rents of Chickpet property and the Plaza. Many people vacated, the rents had to be restructured and a reduction of 8,00,100/- in rent is observed.

The above proposal was discussed to be approved considering that the same will be audited and proposed in the following AGM as it is unaudited. It was iterated that to do forthcoming financial planning, it was very important to put forth this budget in this AGM. Hence, the AGM could not be delayed.

Approval of above accounts was proposed by: Mr Bhavesh Mehta of M/s. Rajesh Jewells and seconded by: Mr D V Ramesh of M/s. Davanam Jewellers Pvt Ltd

- Appointing of Auditors: Mr. Ramaraj and Co. has been carrying out the tasks satisfactorily and the Hon. Treasurer and the Board proposed and members approved to continue with them for the following year too.

1. Query: Why is the TDS of 31,50,000/- still pending?

Clarification: An advance and demand of 4,50,000/- is also paid. It sums up to about 36,00,000/- rupees. The Income Tax Dept. has levied penalties for over 5 years and JAB has gone for appeals. This is pending for four years but the chances are high that all the appeals will be won.

2. Query: What are our bad debts?

About 1,41,000/- bad debts is being written off this year of Mr. Pathi Mahesh of M/s. Shankarnarayana Jewellers. Owing to his sad demise, there were no ways of recovering these debts. Hence, they were written off.

Reappointment of auditors Ramaraj and Co. was proposed by: Mr. Bhavesh Mehta, M/s. Rajesh Jewells and seconded by: Mr. Achutha R Shroff, M/s. Geetha Jewellers.

3. Query: Shouldn't we raise a provision for rents and record GST only when payment is received?

Invoice has been raised only for received rents and not for the due rents. This will be paid off in the next seven days.

- Appointing Local Auditors:

Previously appointed local auditors were Mr Shankar Prasad, M/s. Rajashree Jewellers and Mr. Achutha R Shroff of Geetha Jewellers.

Mourning was observed for the demise of Mr. Pathi Mahesh, the past President, JAB and cherished moments were shared by Mr. Prashant G Mehta in fond memory of him and deep association with him for 40 years. He also mused that he was the foundation stone for export business among them. Today, this port is number one in India.

The outgoing director, Mrs Venkatesh Babu offered his condolences and initiated discussion on mandatory Hallmarking. In this regard, he shared that the Ministry of Consumer Affairs has deemed that the hallmarking of Jewellery Trade should be made mandatory from 1st June 2021. He introduced Mr. Davanam Ramesh, the CEO of Davanam Jewellers Pvt. Ltd. and asked him to share his thoughts.

Mr. Davanam Ramesh about Mandatory Hallmarking:

He said that from last twenty years, the jewellers are supporting hallmarking, but the problem is that from 1st June 2021 it is being made mandatory. The difficulty lies in the infrastructure and not hallmarking perse. There are only 940 hallmarking centers in the country.

Highlights:

1. Only a jeweller who is registered with BIS can sell jewellery.
2. A jeweller can only sell hallmarked 14K/18K/22K jewellery.
3. A registered jeweller can also sell jewellery hallmarked by others with appropriate records maintained.
4. Selling hallmarked/non-hallmarked jewellery without registration will be against the law and can attract penalty or imprisonment.
5. The current stay order states a small portion of the Act/Order and may be lifted.

Jewellers residing in the outskirts of cities will face issues specially to commute during the pandemic. Some other challenges:

1. Jewellery should be hallmarked before selling it to the customer. Retailers, wholesalers, importers, and manufacturers should all register.
2. Exemptions are given to those who sell bullion, karigars (not confirmed), exporters, jewellery less than 2 gms, logistics, jewellery in production and that is repaired.
3. For coins and silver, it is voluntary.

Post registration steps were informed.

An appeal has been made that only before a sale, jewellery can be hallmarked and not if the customers give their gold and get the product manufactured. The constitution has permitted the customer to buy any different caratage. Hence, an appeal has been made to allow hallmarking for all caratages. However, this should not stop us from registering. Underkaratage is also being addressed with the government. Concern has been expressed that during exhibitions, exhibits should be allowed to be displayed and if the sale is made then they will be hallmarked and dispensed. Antique jewellery cannot be hallmarked. Awaiting clarification.



Query: Getting the registration is not easy due to governmental policies.

Response: These processes are digitalized and have been eased out provided all documents are in place.

Query: What exactly is the stay order for?

Response: Infrastructural drawbacks have been highlighted. Request to remove restriction on number of karats. Penal provision to be reconsidered at least till 14th June 2021. The 3-year cap for registration to be removed.

Query: Should the hallmarking charges be displayed in the store as well as mentioned in the bill?

Response: Affirmative. The act says it is mandatory to be mentioned in the invoice, but it is ambiguous and awaits clarification.

Query: What happens to the jewellery in current stock which is below 14K and above 22K?

Response: As per the law it should be liquefied.

A detailed demo was presented by Mr. Goutam M Kothari to inform about the end-to-end registration process for hallmarking.

Mr. G.V. Sridhar shared his thoughts about the positive sides of hallmarking.

Mr. Suresh Ghanna welcomed the new elected directors: Mr. Prashanth Mehta, Mr. Chetan Mehta, Mr. Srinivas R and Mr. Niranjana Pamdi and extended gratitude to retiring members.

The retiring directors and the newcomers expressed their joy of being an important and integral part of the association and thanked everyone who held their hands and let them come this far.

Open Forum:

1. Mr. Manjunath, Hastalakshmi Jewellers: What is the rent due which has been let out under Chickpet property? What's the status of recovery if the rent?

Response: There are two tenants. Eviction orders have been sent out to both, very soon the orders may be received. Priyadarshan's rent due amount is Rs 10,20,000/- The same is due from Oct 2019.

2. Mr. Vivek B Chand, Rajarathnam's Jewells: Will the accounts of this financial year be kept on hold till the next financial year or will it be audited before that?

Response: It will be audited in the due course, in fact, it is already submitted. The following year, both years' accounts may be presented.

Highlights of Kodagu Project: Presented by Mr. Srinivas R

Fund collected: Rs 15,50,000/-

Flood Relief Project was taken up in the Vanachal Village.

Number of houses: 52

They lack the basic amenities of travel, electricity, infrastructure, etc.

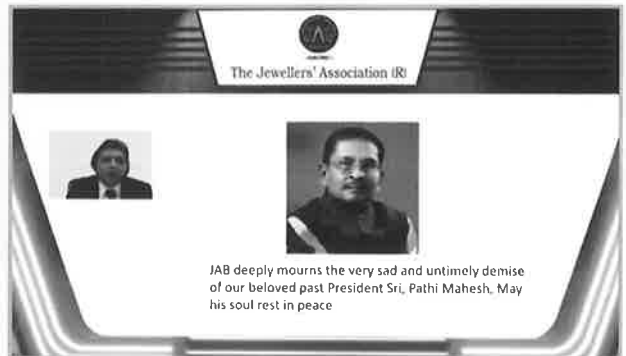
