This year was a season of great momentum for the Jewellers' Association of Bengaluru (JAB). Every initiative — whether in the boardroom, exhibition hall, sports arena, or community space — carried the spirit of collaboration, growth, and pride in our shared craft. Our members came together not just to discuss the future of the trade, but to actively shape it.

### Industry Forums & Knowledge Sharing

We began the year's activities with the **Retail Jeweller Forum held on 20th March 2025** at Sheraton Grand — a gathering that felt more like a reunion of ideas than just a meeting of people. The air buzzed with conversations on consumer trends, store experiences, and the art of balancing tradition with modern retail strategies.

Soon after, the **Bullion Committee Meeting held on 22nd March 2025**, led by our dedicated Chairpersons Mr. N. Vidya Sagar and Mr. Suresh Kumar Ganna, tackled some of the industry's most pressing challenges — from ensuring sustainable bullion sourcing to fostering stronger cooperation between traders and retailers. Energy levels soared during the **IJS Tiritiya Roadshow held on 15th March 2025**, at The Chancery Pavilion, where renowned motivational speaker **Mr. Deepak Shinde** delivered an electrifying talk. His words reminded us that in business, as in life, vision and courage often outweigh resources.

### Advocacy & Industry Representation

Advocacy has always been at the heart of JAB's work, and this year was no exception. A high-level meeting with **Additional Commissioner of Police, Sri Vikas Kumar Vikash, held on 11th April 2025** gave voice to industry concerns over hallmarking processes, security during material transit, theft prevention, and insurance safeguards. It was more than a discussion — it was a commitment to building trust and safety across the trade.

Celebration was also in the air when we felicitated **Shri Prahlad Joshi Ji**, Hon'ble Union Minister, on the milestone of **25 Years of Gold Hallmarking in India**. This moment recognised not only a policy achievement but also the trust it has fostered between jewellers and customers. And at the **Golden Girl Awards – 3rd Edition held on 26th April 2025** at Shangri-La, the spotlight shone on women entrepreneurs whose creativity, resilience, and leadership continue to redefine the industry's boundaries.

### Education & Youth Development

The **Gnana Jyothi GST Seminar held on 21st May 2025** drew a keen audience to the FKCCI Auditorium. GST compliance briefing by the Assistant Commissioner of GST, a session on digital transformation in the jewellery industry by **CA Venkataramani S**, and an awareness session by the Police Department on precautionary measures to prevent theft and fraud.

### Trade Exhibitions & Leadership Insights

The **7th South Jewellery Show held between 28th & 30th June 2025** at BIEC was once again a spectacle of craftsmanship and commerce. For three days, manufacturers, wholesalers, and retailers converged under one roof, forging partnerships and showcasing designs that reflect the soul of Indian jewellery-making. The **Leadership Conclave** added another layer of depth to our calendar. This wasn't just a series of speeches — it was a crossroad of ideas. Various Sessions handled by experts of the field with cutting-edge topics like AI and blockchain in jewellery, strategies for retail merchandising, bullion hedging, astro-gemmology. The highlight of the Conclave was the leadership Session by motivational speaker **Mr. Ujjwal Patni**. He delivered an electrified and awakening session on Jewellery business management.

### Community Engagement & Sports

Beyond commerce and learning, JAB knows the value of community. **The Jewellers' Association Badminton League (JBL) held on 13th July 2025** at KBA brought together 120 players in a day filled with smashes, drop shots, and plenty of laughter. **Proceedings of the 50<sup>th</sup> Annual General Body Meeting held on Sunday, 17th November 2024 at Four Seasons Bengaluru at Embassy One, Bellary Road, Ganga Nagar, Bengaluru - 560063.**

**Mr. Kishore M flagged off the event welcoming everyone and hosting the event.**

**To begin with, the board urged the members of JAB to share their experiences as the AGM was adjourned by an hour due to the lack of quorum.**

Mr. G. V. Sreedhar, the Mentor of JAB was invited upon stage to share his experience of the past one year. In the meantime, Mr. B. R. Ashok Kumar from GJ Gold requested to seek a clarification on the confusion everyone had about the JAB rates and to educate everyone on how it is calculated, its discounts and how it should be followed.

With a warm greeting, Mr. G. V. Sreedhar clarifying about the rates, said that everyone is under an impression that the association is fixing the rates. He said that if the rates are lower than the federation, customers will be happy but if they are higher than the federation, they will debate. So, he said the smart way to tackle the issue is to follow the rates of the association. Continuing, he said that the industry is being driven by the corporates. He clarified that the gold rates were changed 3 months ago with the permission of the Board and that what impacts the trade is **"Today's gold rate"** displayed on the internet. Currently it is being given at 92.3%. He also said that the rate is unanimously accepted and uniformly maintained without any disputes anywhere. He also clarified that this is the decision of the board. Coming to the point how this needs to be handled, he said "we are currently taking a leftover share by the corporates and being satisfied with it. The upcoming generation is not appreciative of the current ways of working." He said if the mid segment jewellers don't step forward and work towards the change, everyone will end up becoming the employees of the corporates. He urged the board to conduct a workshop for small scale and mid segment businessmen to cope with this situation.

Mr. Guru from the audience purported that there should be a fair division of profits among the manufacturers, wholesalers and retailers.

Mr. Chethan Kumar Mehta, the President of JAB, also a manufacturer, reported that a few days ago there was a conference held in Calcutta: the ICC conference. He said that this cycle of the 3 categories suffering was discussed in the conference. He opined that the consumers cannot be blamed for this situation: it is the manufacturers, the wholesalers and the retailers who should take charge of the crisis. He elaborated that the reason for the decadence in profits is because everyone wants to sell for lesser prices, want more business and newer clients. He concluded that the fair margin sharing should be implemented among all 3 segments. He suggested that these 3 pillars of the industry must uplift each other working hand in hand. He said "firstly, we should respect and value the business. Secondly, there should be a standardization in pricing and it should be followed in a unison."

Mr. B.R. Ashok Kumar from GJ Gold put forth the grievance that the customer compares the Insta Mart rate versus JAB rate and bargains and that few people are not following the JAB rates. Mr. G. V. Sreedhar clarified that it has been verified that in the past 3 months, everyone has followed the rates of the JAB and there is no lacuna in it. However, this was under speculation later.

Mr. B. R. Ajit Kumar rendered some highlights from *Ramayana Dharshanam* written by Sri Kuvempu, to break the ice.

Mr. S. Venkatesh Babu, the past President of JAB addressed the gathering. He encouraged the audience to enjoy what is there today in lieu of grieving about not having it tomorrow. He said the equation of life should be treated as  $80 + 20 = 80$  only. He implied that in the process of chasing the 20% we shouldn't forget the 80%. He motivated the gathering by saying Innovation and Reinvention will help everyone sustain. Being a bullion dealer that he is, he shared that in the earlier times, there was a concealed market. And that it was not an open market.



Rates were being declared and published from Mumbai. He continued that now the dynamics of the trade have changed. Then came the banks who offered to sell bullion but they charged more than the traders. Later came the national traders who ruled the market but they taught how to carry out business. He said every change has improved business and come as a blessing in disguise. **Finally, he mused that “it's our responsibility to have the discretion and restructure ourselves to keep going.”**

Mr. Prakash rose to throw some light on the rates. He said, presently 22 Kt gold is calculated at 93% of the bullion rate and that this is validated by the KJF and it should be adhered to.

#### **Lighting of the Lamp Ceremony.**

The Management Committee of JAB was invited to light the lamp ceremoniously in the following order: The honourable President Mr. Chethan Kumar Mehta, the Vice President Mr. Suresh Kumar Ganna, the Secretary Mr. Ashok Rathod, the Treasurer Mr. Tushar R. V., the Joint Secretary Smt. Megha D, the former President and mentor Mr. G. V. Sreedhar, Mr. N. Vidya Sagar, Mr. Ketan S. Dhruv, Mr. Praveen K. Oswal (in absentia), Mr. Bipin Mehta, Mr. Gautham Kothari, Mr. Kishore M, Mr. Hardhik M. Mathuria, Mr. Abhay Ranka, Mr. Urish Chhajed and Mr. Y. S. Ravi Kumar from the Advisory Board. Smt. Kavitha Sreedhar rendered an invocation song befitting the occasion.

The presence of the past Presidents and Secretaries were recognized with an endearing mention.

Tribute was paid by Mr. Kishore M, director of JAB to the departed souls in their fond memory.

#### **The welcome speech was delivered by the Honourable President of JAB, Mr. Chethan Kumar Mehta.**

Mr. Chethan Kumar Mehta greeted the august gathering warmly and expressed his gratitude to the Board of Directors, Core Committee members and the members of JAB for having given him the opportunity as the youngest President of JAB. He appreciated the collective efforts of everyone and reminisced some of the successes attained under his able leadership thus: He met the National Organizations establishing JAB's presence across the country and paved the way for them to invite JAB for several events; launched initiative to ensure Standardization of Gold and Silver purity; through Gnana Jyothi and other seminars, covered by key topics like PMLA compliance, CAD design, E-commerce with GJEPC for online business insights; utilized the funds from Bangalore Gold Festival to grant scholarship to 220 children of goldsmith and jewellers' staff supporting education in the community; hosted the Silver Show of India and 6 Jewellery Shows making it a record; fostering industry connections and launched Silver Shows in Mumbai and Delhi, started and supported by JAB; one of the leading editors of CNBC-NEWS 18, Ms. Manisha Gupta, visited the JAB office and also covered Akshaya Tiritiya in Bangalore; addressed legal issues including the Chickpet eviction case and ROS issue and not to forget that recently the long pending CVD machine was granted from GJEPC which was supposed to have 50% sponsorship but the 10 lakh worth machine was fully sponsored by GJEPC. Once again, Mr. Chetan Kumar Mehta expressed his heartfelt gratitude to all the decorated dignitaries and mentors and ended the prestigious Presidential speech.

Mrs. Kavitha Sreedhar was honoured by Mrs. Megha for rendering the invocation song with a token of appreciation.

The heart-warming and uplifting State Anthem “Jaya Bharatha Jananiya Thanujathe...” composed by the National Poet Sri. Kuvempu was played before calling the meeting to order.

#### **The Secretarial Report for the year 2023 – 2024 was presented by Mr. Ashok Rathod covering the below highlights:**

- There was a remarkable upsurge in the prices of Gold and Silver.
- Meetings were conducted for Gold and Silver Standardization witnessing a tremendous response for Silver Standardization: the refineries using JAB seal has increased from 6 to 13.
- SOP's to be followed during Elections were created.
- Held PMLA seminar for members under the banner of Gnana Jyothi.
- Seminar was conducted on the application of CAD and its benefits for the manufacturers.
- Scholarships were provided to 220 deserving candidates under Vidya Jyothi Scholarship Scheme.
- GJEPC provided a special discount to all the JAB members to IIJS show for registrations.
- The CNBC group Commodity Editor Ms. Manisha Gupta did an exclusive coverage on Bangalore's Market and Jewellers during Akshaya Tiritiya.
- Seminar was conducted on Gold Metal Loan, for educating on how to avail gold loan to help the manufacturers.
- A special seminar was conducted for the members during the India Gold Conference which witnessed participation from around the world.

- JAB conducted South Jewellery Show and Silver Show of India for the benefit of the fraternity.
- Third Edition of Bengaluru Gold Festival was organized and witnessed a good participation despite the fluctuation in prices.
- Seminar was conducted on TDS and TCS.
- The ROS issue is in the High Court and the responses to the ROS order have been filed with a stay order.

The President Mr. Chetan Kumar Mehta called the 50th Annual General Body Meeting to Order.

Mr. Chetan Kumar Mehta called upon the Confirmations and Proceedings of the 49th AGM held at Taj, MG Road on Sunday, 10th December 2023.

Before confirming the proceeding of the 49th AGM, Mr Ketan S. Dhruv objected and informed about the letter written in the 48th AGM agenda mentioning that it was also emailed in the 49th AGM agenda. In view of this, he put forth that the ROS mentions that the 49th AGM is invalid. He also said that it is at stay currently and the verdict is unknown as of current date. Stating thus, he suggested that the 49th AGM minutes should neither be approved nor disapproved. However, he said that it is left to the AGM to take the decision.

Mr. B. H. Ramchandra asserted that in the last 50 years, any issue was resolved within JAB and was not taken to the Court. He pressed that as this big step of filing a suit was taken against the association the opponent is not deemed deserving to be on the dais. He also ascertained that only after the court passes the verdict, the opponent should be allowed to take the stage.

Mr. Ketan S. Dhruv clarified that they had not gone to the High Court. This was further clarified by Mr. Chetan Kumar Mehta that, as Mr. Ketan S Dhruv and party had approached the ROS, the Board had to take the matter to the Court in view of getting a Stay Order.

Regarding the conversation many JAB members like Mr. R. Srinivas, Mr. Pukhraj etc gave their opinion that the matter should have been solved in the AGM and should not have been filed in ROS. It has not been in the history of JAB that members have filed a case against AGM.

As the arguments escalated, Mr. Chetan Kumar Mehta requested the Mentor, Mr. G. V. Sreedhar to advise further in order to restore the decorum of the meeting. Mr. G. V. Sreedhar quoted the past Chairman of GJC, Mr. Vinod Hayagriv: **"We should follow the footsteps of Jewellers Association of Bangalore."** And also opined that this respect and legacy earned over the years should be maintained. He proposed that firstly, the discussions must be issue based and not egocentric. Secondly, he said, regardless of the issue, no complaints were raised to an external body in the past. He also added that whatever decision the Board has taken, it was taken with the suggestion of past presidents and seniors. He suggested that the matter must be resolved amicably and concluded that Mr. Chetan Kumar Mehta will seek confirmation and the General Body may approve on the premise that this is a legal matter and it will be dealt befittingly in the court.

During the discussion, Mr. Suresh I Dhruv cropped up about the members who had filed the petition with the ROS, the names of the complainants were announced as under:

1. Mr. Ketan S. Dhruv
2. Mr. D. V. Ramesh
3. Mr. Bipin Mehta
4. Mr. Praveen K Oswal
5. Mr. Urish Chhaged (withdrawn later providing a written letter).

After the discussion many members of the Board were under the opinion that Mr. Ketan S Dhruv should not have gone to ROS and the matter should have been discussed and settled in EGM or AGM. Mr. B. R. Ajit Kumar from M/s. Geetha Jewells suggested that we should allow Mr. Ketan S. Dhruv to speak, it's not right on our part that we are not ready to listen to him.

Mr. Ketan S. Dhruv requested the General Body to give him 10 minutes to explain the issue with the presentation.

Mr. Chetan Kumar Mehta once again sought for the confirmation and proceedings of the 49th AGM of 2023.

**Proposed by: Mr. B. H. Ramachandra – M/s Geetha Jewellers**

Mr. Suresh I. Dhruv, a member of JAB opposed for the proposal that as the 48th AGM minutes given in the 49th



AGM was not approved and this proposal was not mentioned in the 49th AGM minutes, the 49th AGM agenda needs to be reconsidered. Mr. Ravi Kumar M/s Sunrise Jewels, added that the minutes of the 48th AGM were not proposed or seconded in the 49th AGM as the minutes of the 48th AGM had a discrepancy. Mr. Chetan Kumar Mehta further threw light on the subject that in the 49th AGM minutes, it was mentioned that only if the 48th AGM minutes were redrafted and submitted, permission would be given to carry out the election. "Hence there was a conditional approval of 48th AGM minutes." Continuing, Mr. Ravi Kumar suggested that sequentially, the minutes of the 48th AGM must be proposed, seconded and approved first, following which the minutes of the 49th AGM must be proceeded with, for confirmations and approvals. Further, Mr. Ravi Kumar iterated that as the matter is in the High Court already, any presentation related to this matter should not be entertained in the current AGM.

**Reinstating the Agenda no. 5 – Reconfirmation of the Proceedings of the 48th AGM held at Taj, MG Rd, Bangalore, on Sunday, 19th February 2023, Mr. Chetan Kumar Mehta called for the confirmation and proceedings.**

Mr. Ketan S. Dhruv apprehended that not being given the requested time for the presentation in view of providing the brief about the ROS matter is against the redraft of the minutes especially when a letter had been submitted, and this needs to be recorded.

Mr. Chetan Kumar Mehta repeated that the approval proceedings of the AGM minutes will be conducted sequentially adhering to the suggestion of the General Body. Hence, the proceedings of approval for 49th AGM will follow after the proceedings of the 48th AGM. On the same lines, Mr. Ketan S Dhruv reiterated that the ROS issue was related to the 48th AGM minutes.

Mr. Suresh I Dhruv pressed for clarification of the 48th AGM minutes whether it was "rectification of the redraft" or "reconfirmation of the redraft". If it was rectification, he wished to know what the original minutes was. In continuation, the General Body maintained that when the Confirmation and Proceedings of the 48th AGM minutes would be called to order, all the minutes stated in the same needs to be brought to light and called for passing. Mr. G. V. Sreedhar suggested that a committee should be set up with 4 or 5 senior members who will investigate the matter and close it in the interest of smooth functioning of the current AGM. Obliging to Mr. G. V. Sreedhar, Mr. Prashanth Mehta requested to include him in the committee as he was the then President for which the redrafting of the minutes was under scrutiny. The General Body objected to this stating that Mr. Prashanth Mehta should not be one of the decision makers as the minutes under scrutiny was the agenda of the AGM which was conducted under his leadership and the deciding authority will be the General Body.

Mr. Chetan Kumar Mehta and Mr. G. V. Sreedhar announced the passing of the Formation of the Committee for the resolution of the above said matter and nominating the Committee members will be taken up in the agenda later and AGM will decide the members of the Committee.

Mr. Y S Ravi Kumar highlighted that the 5 Directors who have reached out to the ROS should be suspended on the premise that this act is disrespectful to the association.

Mr. Chetan Kumar Mehta yet again called for the Confirmation and Proceedings of the 49th AGM.

**Proposed by: Mr. G. Pukhraj Jain – M/s. Anand Jewels & Diamonds.**

**Seconded by: Mr. B. H. Ramchandra M/s. Geetha Jewellers.**

**Moving on, the Election proceedings for 2024 was announced by Mr. Kishore. The order of events was as follows:**

- The General Body raised an objection and pleaded for justification on how a complainant was eligible to contest in the 2024 elections and what is the action taken by the Board in this regard.
- The Board rebutted in response that the ROS has stayed stating that the Show Cause is illegal and in justification affirmed that every member has the right to contest for elections.
- Mr. Chetan Kumar Mehta announced that the opinion of the General Body will be taken at a later stage.
- Sri. T. Saravana, the MLC, Govt. of Karnataka, came over for casting his valuable vote in the 2024 elections.
- The contestants introduced themselves and campaigned requesting for votes in their favour.
- Felicitation of the esteemed MLC Sri. T. Saravana honouring his presence and time.
- The General Body once again intervened referring to the section K (e) on page no. 6 of the by-law book and quoted "Cancellation of the Directorship – If he disrespects the association." The contention put forth was that whoever crosses the boundary of the association and goes against it is deemed as disrespectful towards the association and thus shouldn't be allowed to contest in the election.
- The ROS team member presented the below guidelines for the conduction of Elections 2024 for JAB:
  - No. of contestants were 8 out of which mandatorily 4 must be elected.
  - Any number below 4 like 3/2/1 will be considered as invalid.
  - The timings allotted for casting of votes is from 2:00 pm to 5:00 pm.

The gathering dispersed for lunch and voting and resumed the session after about 45 minutes.

**Reinstating the meeting to order the agenda no. 6 "Approval of Accounts and Audited Balance Sheet, Receipts and Payments; Accounts of Income and Expenditure, Accounts as per statements relating to the year 01-04-2023 to 31-03-2024 prepared by CA and approved by the Managing Committee."**

Mr. Tushar R. V. took over, welcomed the members and reiterated the above-mentioned agenda seeking to clarify if anybody had any doubts about the same.

The General Body pressed that the tenant's case had been in the court from many years and wished to know the status.

Mr. Tushar R.V. Read out the mail sent by the advocate addressing it to the Honorary Secretary, JAB.

"We have filed the ejectment suit against Priyadarshini Cloth Merchant in the year 2019 before the City Civil Court at Mayo Hall. Plaintiff evidence was also recorded and documents were also produced and the matter was posted for your cross Examination. Then there was COVID 19 and the courts were not functioning regularly. In the year 2023, the tenant has filed the petition to transfer the Mayo Hall Court to City Court stating that the tenant is old and has health issues and he could not climb the staircase and hence the case was transferred to the City Civil Court, Kaveri Court Hall no. 28.

It is stated that after the transfer of the case, we are regular in attending the case along with Mr. Tushar R. V. the opposite advocate is delaying the matter either one or other reasons. The honourable judge is very lenient in granting adjournments. Further the opposite advocate also filed frivolous application of contempt of court against me and that application was dismissed after 6 months. Again, another application was filed for rejection of the plaint which was dismissed on 13-11-2024.

Now the matter is posted for Cross Examination to 25-11-2024. It is to be noted that the City Civil Court is loaded with more cases much earlier to our case. I will take all the possible and necessary actions to complete the case at the earliest.

Thanking you."

The General Body questioned how the JAB's advocate was agreeing to all the delays and other proceedings that had taken place.

Mr. Tushar R. V. clarified that due to the provisions available to the opposition party especially because he is



physically challenged, despite objections raised by the advocate appointed by the association, not much could be done yet. It came to light that the rent of about 45 to 48 lakhs is overdue from the tenant. Mr. R. Srinivas added that when the case was transferred from one court to the other court, neither the advocate nor the association was aware of it until 6 months. The General Body reprimanded accusing and doubting the efficiency and promptness of the advocate debating that should there be a delay of more than 3 months of overdue of rent, the law states that tenants can be evicted. In conclusion, the General Body pressed that the advocate needs to be changed. Upon seeking approval for the same, the General Body instantly approved to change the advocate.

Next up, the General Body wished to know why in the Advance and deposit column, an advance of Rs. 5,89,211/- towards Software Development was shown recurrently for 2 years.

Mr/ Tushar R. V. clarified that it was towards BGF. Further he said as the physical printing of coupons had been stopped and in view of continuous improvements the said amount was being allocated. Mr. Ketan S. Dhruv further clarified that the BGF software is hosted on cloud and due to increase in storage space as well as maintenance this fund is required.

**Proposed by: Mr. B. R. Ashok Kumar, M/s. GJ Gold**

**Seconded by: Mr. G. Pukhraj Jain, M/s. Anand Jewels and Diamonds**

**Approval of Budget for the year 2025 to 2026.**

The General Body commented that the approval should be sought only for next one year whereas it is being taken for 2025 to 26 also as mentioned on page no. 6 which is not the best practice. Also, they pointed out that the income and expenditure is missing out in the column for 2023 to 24. Straightaway it was mentioned for 2025 to 26. Therefore, was this in addition to what was sought previously – Mr. R. Srinivas clarified that as the financial year is not closed yet, it will be mentioned as Estimated Budget although it is for the following year. While the Board expressed that only 3 months was left for the next financial year the General Body suggested that to overcome this issue the AGM should be held in the month of July or August.

The General Body questioned if an additional XRF machine was being invested on for which the Board replied that as the current machine is 5 years old, it's efficiency in terms of accuracy and speed would've reduced. Moreover, it is advisable to possess a technologically advanced or more accurate machine. Mr. R. Srinivas remarked that the new XRF machine could cost around 25 lakhs and 15 lakhs wouldn't be sufficient for which the Board clarified that they are aiming to get a sponsorship from the vendor and the machines are available between 12 to 15 lakhs. In conclusion, Mr. Chetan Kumar Mehta proposed that they should check out a few demos of various machines, have an approval for 22 to 23 lakhs and take a decision while purchasing based on a befitting machine. General Body suggested to seek approval for 25 lakhs for XRF.

**Proposed by: Mr. Manjunath V. M., M/s. Ekadanta Jewellers**

**Seconded by Mr. Y. S. Ravikumar, M/s. Sunrise Jewells**

Regarding Sponsorship, The General Body pleaded to know how much fund was collected from Sponsorships. Mr. Chetan Kumar Mehta responded that unlike earlier, currently the exhibition partners are paying in the form of other revenues and this is not being able to be retrieved. That said, he mentioned that maximum amount is being sought approval for and efforts will be made to save as much as possible from this fund.

Updating of Website and Software: the General Body enquired why a budget of 2.5 lakhs was being set aside every year. The Board clarified that this is towards emails, servers, maintenance, revamping of the website, membership software, at al. The General Body countered that this should not be a recurring expense every year for which the board obliged to revisit this with the vendors and get a couple of revised quotations.

Regarding Temple trust case: Mr. Tushar R V answered that as the advocate has changed, action will be taken abiding by the new advocate's advice.

Mr. Tushar R. V. sought approval for AGM expenses for 2025 to 2026 of 18 Lakhs.

**Proposed by: Mr. Venu, M/s. Jayalaxmi & Co**

**Seconded by: Mr. Dinesh, M/s. M. P. Jewellers**

Legal Expenses was set at 3.5 lakhs but was sought for 5 lakhs in the AGM: Mr. Tushar R. V. mentioned that it includes ROS case, opinions, etc.

**Proposed by: Mr. Premchand, M/s. B. P. Jewells**

**Seconded by: Mr. Venu, M/s. Jayalaxmi & Co**

Mr. G. V. Sreedhar announced that the approved budget will be applicable until the next AGM as they will try and hold the following AGM during July/August month.

Agenda No. 7 was parked aside for later.

Mr. Dinesh from M. P. Jewellers told he has found some discrepancies in Associations weight calibration, so Mr. G. V. Sreedhar suggested to handover the findings and submit to the board and necessary action will be taken and it will be resolved.

Mr. Y. S. Ravikumar from the Advisory Committee suggested that no Board member must be allowed to take up any procurement or contracts/jobs or services for JAB in the interest of transparency. Only third parties should be given this opportunity with a couple of quotations.

- Appreciation and Honour to the JAB staff members.

**Agenda No. 12 – Selection of One Auditor and Two local Auditors for the ensuing year:**

The General Body consented to continue M/s. Ramaraju & Co.,

Mr. Arun Marlecha and Me. Venu were the local auditor names suggested for 2025 to 2026.

**Proposed by: Mr. B. R. Ajithkumar – M/s. Geetha Jewells**

**Seconded by: Mr. Manjunath – M/s. Ekadantha Jewellers**

Mr. R. Srinivas, the internal auditor of JAB raised a point regarding BGF2 that as BGF is a big project, the amount incurred will be huge, but he has noticed that there is no proper quotations for the expenses incurred. Mr. G. V. Sreedhar and Mr. Chetan Kumar Mehta told they will write a letter to Mr. D. V. Ramesh to furnish all the quotations and will get back to AGM regarding the same.

**Agenda No. 11 – Update on Income Tax Notice:**

Mr. Tushar R. V. announced that all the dues were paid post seeking approval from the General Body the previous year and that a judgement has been passed recently by the Supreme Court. As per the judgement, he requested the General Body to comment on the possibility of withdrawing interest on taxes under amnesty scheme. The General Body chose to take a decision after speculating some more whether JAB comes under the purview of non-profitable organization or not.

**Regarding setting up of the committee of 5 members for the scrutiny of the passing of the 48th AGM minutes/ROS complaint:**

The Board requested ascent from the General Body as well as Mr. Ketan S. Dhruv for honouring the decision of the committee. Some members suggested it should be resolved amicably without setting up the committee. Thereafter, Mr. G. V. Sreedhar said that regardless of the decision of the committee, Mr. Ketan S. Dhruv must withdraw all the complaints. He further suggested that the duration of the scrutiny by the committee will be about 90 days. Following which Mr. G. V. Sreedhar proposed that the complainant Mr. Ketan S. Dhruv will withdraw all the complaints immediately on one condition that the General Body must let go of the 48th AGM minutes. At this junction Mr. B. H/ Ramachandra objected for the suggestion and said “if we allow the mistakes done earlier to be removed from the minutes, it will become a precedent for future wrong doings”. The future directors may point all this example and ask to be exempted from their mistakes also, so this should not be allowed. For which Mr. G. V. Sreedhar countered that, this resolution adds to the prestige of JAB as people and members will understand that JAB could successfully handle and resolve even such a tough situation. Moreover, he added, that Mr. Suresh I. Dhruv from the Bangalore Refinery was the first individual to support JAB's AGM. He implored to the General Body that as Mr. Suresh I. Dhruv stood by JAB during difficult times, this is the least JAB could do showing gratitude to him. With respect to the 48th AGM minutes, he proposed on record that “whatever was drafted will be intact and

whatever was redrafted will not be considered subject to the conditional approval of the General Body and the Board.”

Mr. R. Srinivas announced that it should be the decision of the General Body and not the Board to make the redrafted minutes of 48th AGM as null and void.

**Mr. Ketan S. Dhruv agreed to withdraw all the cases. In conclusion, it was announced that unconditionally both parties will withdraw the ROS cases no questions asked.**

In the above view, Mr. G. V. Sreedhar put some points into perspective:

1. The 1st minutes drafted for 48th AGM stands valid and the 2nd minutes drafted will not be considered.
2. The end-to-end procedures and issues related to ROS case will be the duty and responsibility of Mr. Ketan S. Dhruv and will be driven and settled by Mr. Ketan S. Dhruv with the support of the JAB Board as soon as possible.
3. The ROS case and the stay order will be withdrawn jointly.
4. Mr. Ketan S. Dhruv will be able to contest the elections only post closure of the cases and that until then he will not contest in the elections – this was accepted by Mr. Suresh I. Dhruv also.
5. Now that the issue is solved there is no need for any committee for solving ROS issues.

Mr. Ketan S. Dhruv requested an unofficial meeting to be set up exclusively to discuss this issue and close it as soon as possible.

Mr. Chetan Kumar Mehta announced that the Advisory Committee and the Mentor is vital to JAB and should continue their advisory role in the future too.

Mr. B. H. Ajith Kumar briefed the Board about some important points to be kept in mind:

- Firstly, the itinerary didn't include honouring the invocation singer – this was done only after suggestion on the spot - The lamp shouldn't be lit while the song is being delivered.
- The names of the deceased should be rehearsed before reading out the Obituary list on the D-day.
- Emceeing needn't be carried out by one person. Various members of the Board should be given opportunities in a distributed fashion to host different programs throughout the day.
- Every program must be enlisted in the agenda and driven in an organized manner. For example, the Secretariat speech was not listed in the agenda but was invited impromptu to deliver the speech.
- It is suggested to invite a motivational speaker which could be crowd-pulling as well as a good-to-have itinerary.
- An empty page left in the end of the booklet will help in making notes to the members.
- The Branding should be elevated and given more visibility.
- The stairs to the stage should be placed on the side rather than in the front to avoid easy accessibility to the stage. The Mic should be placed far away from the speaker.
- Quoting Indian Institute of World Culture as an example, he suggested to include the below going forward:
- The President must always be available on one side of the stage while the people who seek clarifications will take the podium on the other side and seek answers. Hand mics should be avoided.
- The protocol to be followed during the meeting must be published as an SOP with clearcut description in the hand book as a ready reference to everybody.
- The catering facility and the convening of the meeting should be more organized and disciplined.

**Regarding BGF, he said that:**

- The questions posed to the Chairman of BGF weren't handled or answered appropriately.
- He added that the number of traders has reduced this year in the BGF as the people weren't convinced that the prize distribution was deemed fair.
- He said that none of the suggestions given in the earlier meetings like celebrating get-togethers for a family day; jewellers day; national festivals; paying a tribute to the soldiers from individual businessmen or from the earnings of such special occasions as a homage, have been considered.



- Content driven marketing should replace the traditional marketing via various media in case the profits made out of traditional medium doesn't account to a minimum of 80% revenue. Personalized Instagram content/ WhatsApp status content/Facebook, etc., must be given to the members to help them in marketing.
- In the perspective of assisting Stand-alone traders: Give prominence to deliverables and not focus on the mass or a category alone. In the lines of the suggestions made by Mr. Y. S. Ravikumar, he said prizes should be awarded in a more distributed manner and shouldn't be allowed to be monopolized. Mr. Chetan Kumar Mehta clarified that the prize distribution is system driven and is not done in any schematic way.
- The Board should be more discreet in the selection of ambassadors.

Regarding the above points, Mr. Chetan Kumar Mehta suggested that Mr. B. R. Ajit Kumar should take the lead of BGF 4 and give his time to make it a success. He should put all his thought to reality.

He also clarified that BGF 3 was very transparent and no extra favours were done to corporates, here everyone was treated same and all directors have put their complete efforts for our industry.

Mr. Tushar R. Vannounced that unclaimed prizes worth roughly around 400 grams of gold and 20 kgs of silver was lying with the association from BGF 1 and 2. The unclaimed prizes of BGF 3 is yet to be known. He said that these unclaimed prizes cannot be given to the stores as they will not pay TDS. Hence, he sought for the General Body's opinion on whether they can be used as a part of BGF 3 and give away more prizes than planned or declare it in BGF 3, pay TDS and keep it back in the association. Mr. Ketan S. Dhruv suggested thus: The best way to reinstate the trust of the traders or participants in BGF is to increase the number of prizes and do a revised BGF.

**However, Mr. Tushar R. V. sought the opinion of the General Body whether this activity should be carried out in BGF 4 for all the unclaimed prizes of BGF 1, 2 and 3. The General Body advised to taken the opinion of the auditors on this matter.**

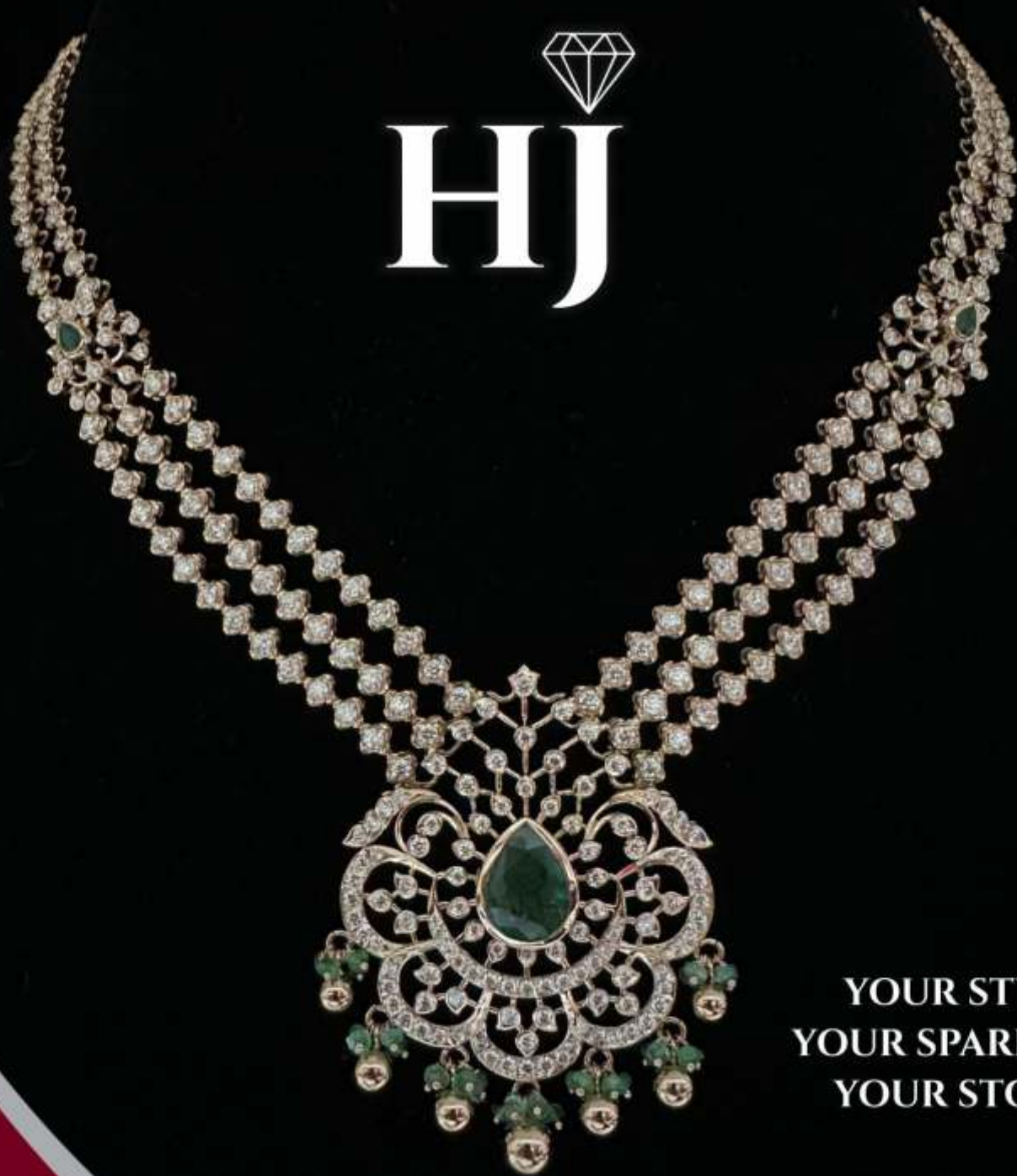

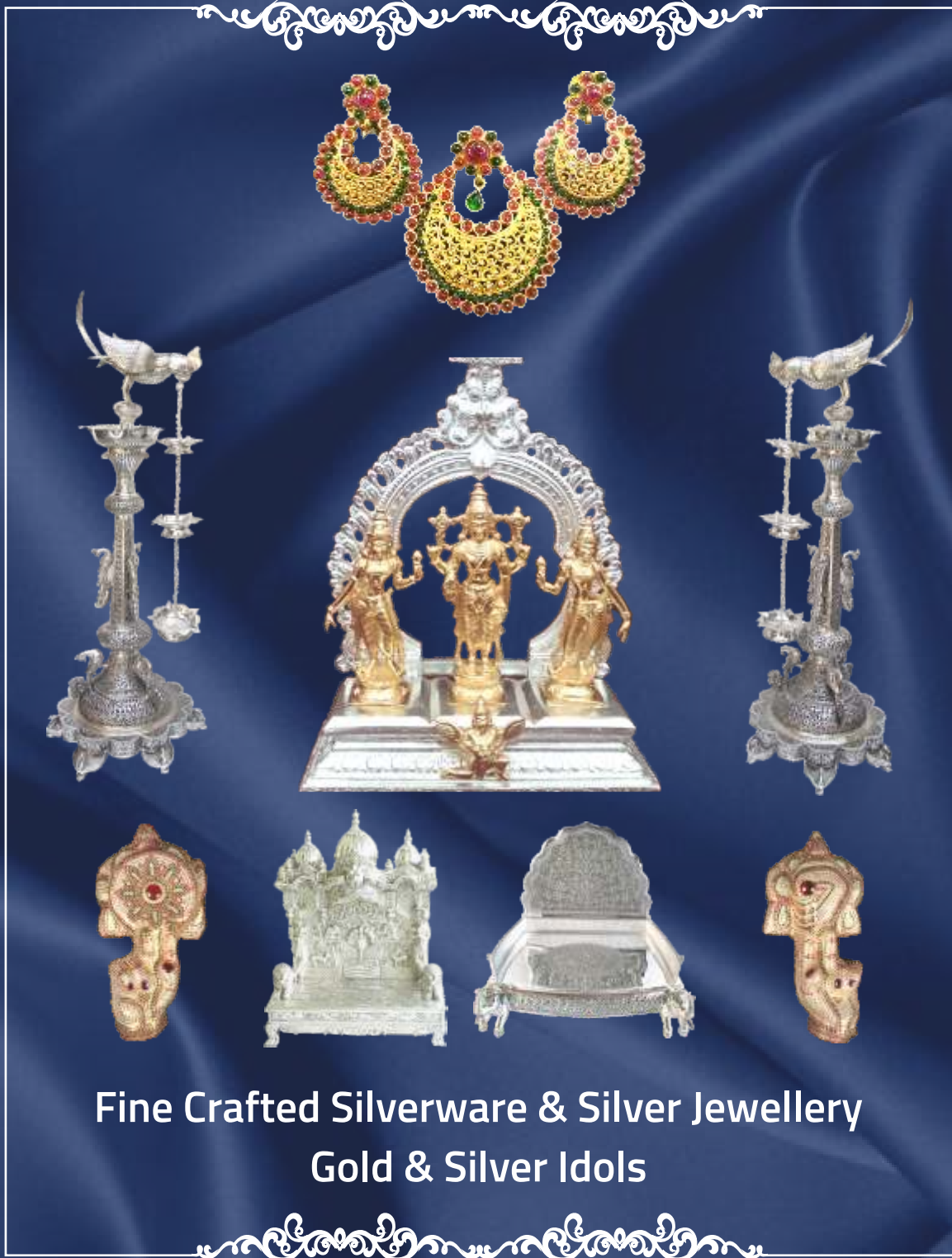

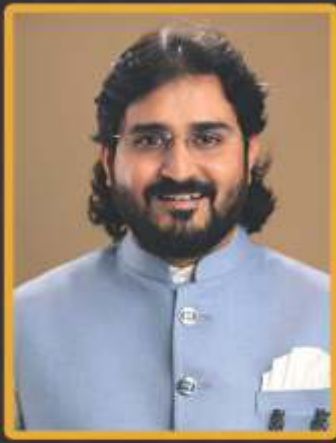
